**SUBJECT:** Confirmation of Canvass of November 5, 2024, General Municipal

Election

#### **RECOMMENDATION:**

Adopt Resolution No. 24-\_\_ entitled "A Resolution of the City Council of the City of Goleta, California, Reciting the Facts of the General Municipal Election Held on November 5, 2024, and Such Other Matters as Provided by Law."

#### **BACKGROUND**

On May 21, 2024, the City Council adopted Resolutions 24-32 and 24-35, calling a General Municipal Election to be held and conducted in the City of Goleta, Santa Barbara County, California, on Tuesday, November 5, 2024, as required by law, to:

- Elect the City of Goleta Mayor for a four-year term
- Elect two members of the City Council for four-year terms one each in District 3 and District 4
- Submit to the voters Measure G2024 Agricultural Land Initiative Extension Measure extending the term of Measure G2012 ("Heritage Farmlands Initiative") by an additional twenty years upon the expiration of G2012 and to take effect on December 31, 2032

The General Municipal Election was held in the City of Goleta on Tuesday, November 5, 2024.

The City's General Municipal Election was consolidated with the November 5, 2024, Presidential General Election, and the Santa Barbara County Registrar of Voters was authorized to canvass the returns. Staff is recommending the City Council adopt Resolution No. 24-\_\_ entitled "A Resolution of the City Council of the City of Goleta Declaring the Results of the General Municipal Election Held on Tuesday, November 5, 2024, and Such Other Matters as Provided by Law" (Attachment 1).

Meeting Date: December 17, 2024

#### DISCUSSION:

The County of Santa Barbara Registrar of Voters conducted the election on behalf of the City of Goleta and is required to provide to the City a Certification of Election Results. On December 4, 2024, the City of Goleta received certification of result of the canvass and summary report for the City of Goleta from the County of Santa Barbara Registrar of Voters, attached as Exhibit A to Attachment 1.

Upon completion of the canvass of the votes and before installing the new officers, the City Council must adopt a resolution reciting the fact of the election and declaring elected the persons for whom the highest number of votes were cast for each office.

The City of Goleta received the Certificate of Election results from the County of Santa Barbara certifying the canvass of the votes for the City of Goleta Mayor; two members of the City Council for four-year terms, one each in District 3 and District 4; and for Measure G2024 Agricultural Land Initiative Extension Measure extending the term of Measure G2012 ("Heritage Farmlands Initiative") by an additional twenty years upon the expiration of G2012 and to take effect on December 31, 2032.

The following results are based upon the official canvass of the returns for the General Municipal Election held on Tuesday, November 5, 2024:

- **City of Goleta Mayor:** Paula Perotte, Mayor (63.38%) was elected. The Mayor's seat is for a four-year term.
- **Members of the City Council**: Jennifer Smith, City Councilmember for District 3 (64.34%), and Stuart Kasdin, City Councilmember for District 4 (62.86%), were elected. The City Council seats are four-year terms.
- Measure G2024: The official results show that the voters passed Measure G2024
   Agricultural Land Initiative Extension Measure by a 73.32% majority vote.

#### **FISCAL IMPACTS:**

The Santa Barbara County Elections office provided the estimated cost of \$58,100 for conducting the Election. Staff included \$53,000 in the City Clerk Division's Election Costs Account 101-10-1300-54002 for FY 2024-25. Staff will return to the City Council to request an appropriation to cover the additional cost if necessary. Actual election costs are expected to be known by February 2025.

#### **ALTERNATIVES**

Before the City Clerk may issue the Certificates of Election and administer the Oaths of Office, the City Council must adopt Resolution No. 24-\_\_, declaring the results of the November 5, 2024, General Municipal Election. There are no viable alternatives to the recommended action.

#### **RESOLUTION NO. 24-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLETA, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2024, AND SUCH OTHER MATTERS AS PROVIDED BY LAW

**WHEREAS**, a General Municipal Election was held and conducted in the City of Goleta, California, on Tuesday, November 5, 2024, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast and received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, the Santa Barbara County Clerk/Registrar of Voters canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLETA AS FOLLOWS:

#### **SECTION 1.**

That the whole number of ballots cast at the precincts including Vote by Mail ballots and provisional ballots are detailed in the Official Canvass attached as Exhibit A.

#### SECTION 2.

That the names of persons voted for at the election for City of Goleta Mayor, were as follows:

#### **SECTION 3.**

That the names of persons voted for at the election for City of Goleta City Councilmember District 3 and City of Goleta Councilmember District 4 were as follows:

## **SECTION 4.**

That the local Measure voted upon at the election is as follows:

## **SECTION 5.**

That the number of votes cast in each precinct and the number of votes cast in the City for each of the persons above named for the respective offices for which the persons were candidates and for and against the Measure were as listed in Exhibit "A" attached.

#### **SECTION 6.**

That the City Council does declare and determine that as a result of the election:

- A. Paula Perotte was elected as City of Goleta Mayor for the full term of four years.
- B. Jennifer Smith was elected as Member of the City Council, District 3 for the full term of four years.
- C. Stuart Kasdin was elected as Member of the City Council, District 4 for the full term of four years.
- D. A majority of the voters voting on Measure G2024 Agricultural Land Initiative Extension Measure did vote in favor of that measure, and that the measure was carried, and it shall be deemed adopted and ratified.

#### **SECTION 7.**

The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of votes cast in the City; (2) The names of the persons voted for; (3) The measure voted upon; (4) For what office each person was voted for; (5) The number of votes given at each precinct to each person, and for and against the measure; (6) The total number of votes cast for each person, and for and against the measure.

## **SECTION 8.**

That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

## **SECTION 9.**

That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
