SUBJECT: Notice of Completion for 2022-2023 Pavement Rehabilitation

Project

RECOMMENDATIONS:

A. Adopt Resolution No. 24-___ entitled "A Resolution of the City Council of the City of Goleta, California, Authorizing the Filing of a Notice of Completion for the 2022–2023 Pavement Rehabilitation Project"; and

B. Direct the City Clerk to file a Notice of Completion with the County Recorder's Office.

BACKGROUND:

The Public Works Department solicited competitive bids for the 2022-2023 Pavement Rehabilitation Project (Project) in the Santa Barbara Independent on June 16, 2022, and June 23, 2022. Public Works staff also posted the contract documents on the City's website and the City's PlanetBids portal. The bids were opened virtually via PlanetBids on July 14, 2022. The City Council awarded the Project at the August 16, 2022 City Council meeting to the lowest responsive bidder, Granite Construction Company Inc. (Granite). The Project began on November 9, 2022, and construction was completed on October 26, 2023.

DISCUSSION:

On November 9, 2022, Public Works staff issued Granite a Notice to Proceed to commence work on that day. This project's scope includes resurfacing pavement sections with hot mix asphalt, slurry seal placement, roadway reconstruction, curb ramp reconstruction, and pavement striping replacements at various locations throughout the City.

The streets that were resurfaced or reconstructed are portions of: Cannon Green Drive, Chapman Place, Davenport Road, Elmhurst Place, Freeman Place, Greensboro Street,

Hillsboro Street, Hillsboro Way, Lowell Way, Los Carneros Road, Cathedral Oaks, Armstrong Road, Covington Way, Covington Place, Camino Caseta, Caseta Way, Camino Laguna Vista, Camino Talavera, Camino Venturoso, and Camino Viviente.

Public Works staff recommend adopting the proposed resolution to facilitate the final close-out of this project (Attachment 1). A Notice of Completion pursuant to Civil Code section 9204 is recommended for approval and direction to be filed with the County of Santa Barbara, County Recorder Office (Attachment 2).

The Project was awarded at the August 16, 2022, City Council meeting for the not-to-exceed amount of \$4,550,000. In addition, contract contingency for the project was approved in an amount not-to-exceed of \$910,000. The final construction cost was \$4,853,997.51. The construction cost is greater than the construction award cost by 7% which is within the project's 20% contingency, this was a result of an increase in quantities of material covered by the contingency fund.

ALTERNATIVES:

The City Council may elect to direct staff not to file a Notice of Completion for this project. If a Notice of Completion is not filed, then the project will not be officially closed out.
