### **BACKGROUND:**

Each year, every department within the City of Goleta presents an Annual Work Program to the City Council before the adoption of the next Fiscal Year (FY) budget. The Annual Work Program serves to inform the Council of progress on existing work commitments, while also allowing the Council to recognize workloads, staffing levels and establish work priorities. On March 4, 2025, the Neighborhood Services and Public Works Departments Work Programs were presented to and adopted by City Council.

### **DISCUSSION:**

The purpose of the Parks and Recreation Commission is to advise the Goleta City Council and staff on matters related to public parks, open spaces, beaches, and indoor and outdoor recreational facilities and opportunities in Goleta. In accordance with Goleta Municipal Code 2.12 (Ord. 23-23), staff are providing a bi-annual update of the division operations to better assist the Commission in their advisory role to City Council.

The purpose of the Fiscal Year 2025-2026 Work Plan is to provide the Parks and Recreation Commission with an understanding of the Council's expectations for both the Parks and Recreation and the Parks and Open Space Divisions.


