# **RECOMMENDATION:**

- A. Conduct candidate interviews for the Public Engagement Commission, the Library Advisory Commission, and the Public Tree Advisory Commission; and
- B. Select two nominees (one Youth Member and one Regular Member) for the Public Engagement Commission Mayoral Appointment; and
- C. Select two nominees for the Library Advisory Commission Mayoral Appointment; and
- D. Select one nominee for the Public Tree Advisory Commission Mayoral Appointment; and
- E. Continue this item to the November 19, 2024, City Council meeting for two Mayoral Appointments to the Public Engagement Commission, two Mayoral Appointments to the Library Advisory Commission, and one Mayoral Appointment to the Public Tree Advisory Commission.

# BACKGROUND:

# **Public Engagement Commission**

The Public Engagement Commission is authorized by Goleta Municipal Code Section 2.19.20. The purpose of the Public Engagement Commission shall be to advise the City Council and staff on matters related to public engagement in City government and governance. The Public Engagement Commission shall be composed of seven (7) members. One member shall be a Youth Member. Members of the Public Engagement Commission shall be no limit on the number of terms members may be appointed. The Youth Commissioner shall serve up to a two-year term.

On June 10, 2024, Jessica Avila-Ruiz Youth Member notified staff that she would be moving and submitted her resignation for the Public Engagement Commission. The Youth member term would have expired September 2025. Also on September 4, 2024, Silvia Uribe notified staff that she would no longer be able to serve on the Commission. Silvia Uribe's term would have expired November 2025.

# Library Advisory Commission

The Library Advisory Commission is authorized by Goleta Municipal Code Section 2.14.020. The purpose of the Library Advisory Commission shall be to advise staff and the City Council on matters affecting the Goleta Valley Library representing the interests of the library's patrons by recommending programming and services for the library.

The Library Advisory Commission shall advise the Library Board of Trustees (Board) and increase community participation in library issues by analyzing the library's needs, considering goals, anticipating future needs and problems, acting as a liaison, acting as a sounding board, and helping to develop consensus for advisement to the Board.

The Library Advisory Commission shall be composed of five members. Two members of the Commission shall be appointed by the Mayor with the approval of the City Council according to the process established in Goleta Municipal Code Chapter 2.15. Three members of the Commission suggested by the County Board of Supervisors shall be appointed by the Mayor to represent the unincorporated service area of the Goleta Valley. There are four vacancies on the Library Advisory Commission.

In October 2024, both Stephanie Drake and Lori Goodman (both Goleta Incorporated Area members), notified staff that they would be resigning from the Library Advisory Commission. Stephanie Drake's term would have ended June 2025. Lori Goodman's term ended June 2024.

There are two additional vacancies to be filled, Marcos Aguilar (Isla Vista Community Service District) and Dave Callanan (Unincorporated Library Area). On November 5, 2024, the Santa Barbara County Board of Supervisors will consider approving and suggesting to the City of Goleta the reappointments of Marcos Aguilar (Isla Vista Community Service District) and Dave Callanan (Unincorporated Library Area) to the Library Advisory Commission.

# Public Tree Advisory Commission

The Public Tree Advisory Commission is authorized by Goleta Municipal Code Section 2.11.020. The purpose of the Public Tree Advisory Commission shall be to hear appeals of decisions on the planting and removal of public trees as provided under Section 2.11.010, and to provide advice to staff and the City Council on matters related to the Goleta Urban Forest. The Public Tree Advisory Commission shall be composed of five members.

On August 7, 2024, Kalia Rork submitted her resignation and notified staff that she would no longer be able to serve on the Public Tree Advisory Commission. Kalia Rork's term would have ended February 2027.

# DISCUSSION:

Appointments to the Public Engagement Commission, Library Advisory Commission, and the Public Tree Advisory Commission follow the normal appointment process under GMC Section 2.15.040 (B). At the conclusion of all interviews, each Councilmember shall announce the Councilmember's preferred candidate(s) for the interviewed position(s). The City Clerk shall compile a list of candidates for each vacancy based on the Councilmembers' selections.

In anticipation of the expiring terms for the Public Engagement Commission, Library Advisory Commission and the Public Tree Advisory Commission, the City Clerk's office published requests for candidate applications on the City website, the Monarch Press, Channel 19, the local adjudicated newspaper, GovDelivery Bulletins, social media sites, and generated press releases.

#### Why are you interested in serving on a board, commission or committee?

The built environment has a profound effect on the social world—it can bring peace or increase stress, enrich lives with beauty or afflict them with ugliness, foster prosocial interactions or divide groups and suppress activities, increase or decrease resiliency in the face of climate change. I've always had a strong interest in architecture and gardens, and not merely the formal beauty of the structures but their social use and context. I'm a lifelong Goletan; I've walked the Ellwood bluffs since preschool. I've watched the area develop, sometimes with appreciation, sometimes with regret. I love this place and I plan to live here the rest of my life. Especially with the influx of building projects I would like to contribute my vision to how the city develops. I can't bring the wisdom of professional experience but I believe I could brings a valuable perspective to the planning process as a non-driving, disabled millennial who grew up the trailer park.

#### Describe your qualifications, interest, education, and/or knowledge regarding Historic Preservation of buildings and structures and /or the preservation of Archaeological and Tribal Cultural Resources?

I have an amateur interest in history, archeology, architecture, and landscape. I also grew up as the beneficiary of previous historical commission work preserving Sextant House through the compromise with the hotel, Barndall Station. Most importantly for me I spent many happy days rambling through the old gardens of Stow House. Linda Foster, the caretaker of Stow House from 90s to the 00s was a family friend and I took art lessons from her from age ten. We would go out and draw plants, old stone walls , the machinery in the stable yard, and views of Los Carneros. Over those many years I watched a lot of changes and heard a lot of gossip about the running of grounds--the decision that the Lemon Festival was too hard on the grounds, the discovery of the old drive lined by olive trees, the competing needs of blacksmith, wedding venue, school tours, Civil War reinactors, train enthusiasts, large and small, plant conservationists, etc. So I would say this has given me a window into how multifaceted historic properties can be--and how richly they can benefit the community.

#### Describe your qualifications, experience, and education, and list any technical or professional requirements you have relative to the duties of the board, commission or committee to which you are applying.

I'm a recent LEAD Goleta grad and the program educated me on the inner workings of the city. Actually, Peter Imhof's presentation on the coastal commission and design review board was my favourite and it cemented my conviction that this is a part of city life I would like to participate in. I have a professional background in philosophy—I have my MSt from Oxford University and my PhD from Indiana University, Bloomington. I concentrated in ethics and aesthetics, especially Plato and Hume on the virtue of justice. That might sound inapplicable to a design review board but the nature of the city is of fundamental importance to Plato and I always find it useful to read him alongside Jane Jacobs. I also find the ancient history of the city fascinating—I'm a bit of a Mesopotamian nerd—and again looking at the archeological record always seems to cross-connect with issues from infrastructure channels like Not Just Bikes. My only formal training in architecture was a class on Roman architecture, for which we read Vitruvius's Nine Books of Architecture and studied a bunch of archeological examples. But I have long indulged an amateur's passion for architectural and landscape history, formal gardens, mazes, topiary, etc. And I have supplemented books with my own travel experience when possible. In the last five years I've been learning a great deal about gardening. I love trees and native plants and I've been redoing our my garden to increase the native plants and environmental benefits. I'm signed up to take Environmental landscaping I and II through SBCC Open Extension. I think I will probably get the Green Gardener and environmental landscape certificates within the next year (or two if there are scheduling issues).

#### Question applies to multiple boards What are your goals in serving on the board, commission, or committee to which you are applying?

I would try to balance multiple goals 1. Pedestrian friendliness/ bike and bus accessibility— As a pedestrian I often encounter enclosures that prevent a natural path for no particular reason. (E.G. a fence or wall that blocks passage to a bus stop and necessitates a lengthy detour. By looking at plans with a pedestrian eye I would hope to catch and address these spots. There are further issues of shade, shelter from traffic, adequate bike parking, etc, but this would be a start. 2. Lasting architectural beauty—Much as I love the Arts and Crafts tradition and the Spanish-Moorish and ranch styles that currently characterise much of Goleta's architecture, I would rather have a building with good structural lines outside those styles than one with the trappings of the 'right' style but bad proportions. In fact, I personally would be glad to see some buildings of a soft modernist style in a distinctively Goletan style. E.g. to draw on the Ellwood Station tiling patterns in new ways. 3. Increasing Goleta's environmental assets—I believe that we can use even the smallest opportunities to increase wildlife habitat and climate resilience. I also think we should look for ways to use impact mitigation measures to create parklet-like spaces with a strong design component and artistic impact. For instance using required tree planting to form a wooded alley, a circle of trees to create our own sort of Ashdome, or a screened nook with a fountain and a tranquil atmosphere. I think green spaces of this sort would have great social, economic, and environmental value. I love the formal gardening tradition and I think it would be exciting to try to bring some of these old forms—hedge maze, topiary, color-themed plantings, etc into being with native plants.

Question applies to Historic Preservation Commission What do you believe to be the role of the Historic Preservation Commission?

I believe its role is to preserve for the community objects (buildings, trees, areas, relics, views, etc) of significance to the landscape and its inhabitants' history. I think the listen and evaluate claims of historical merit from different groups and voice the community's interest in preserving its history when that is threatened by development or neglect. I think is is their role to ensure that multiple communities' history is represented and that historical significance is not restricted just to the what is deemed picturesque by one group. For instance, in the current debate about the old airport hangers I think is is quite important that they should be preserved. My experience with the old machines the in the Stow House stable yard taught me that even rusty farm equipment is valuable and beautiful to a whole host of unexpected people. If it is gone, it cannot be re-created; if it is preserved it can enrich the lives even of those who don't know or care about it. I think it has a special role in ensuring that the Chumash and other tribal heritages are preserved. These are particularly and risk and in light of past losses and injustices it is important that further losses be prevented, and that tribal voices about what is culturally significant are heeded.

I'm a proud Goleta resident, ready to learn and listen to different voices, happy to build consensus and play my part in the commission's advising and fact-finding role. I am also eager to serve my community in this time of mandated building where there will be more pressure than ever to bulldoze anything 'in the way" of new projects. I would be ready to push for halt, abatement, or concession as needed on behalf of the community, present and future. As mentioned above I think my experience with Stow House has given me some insight into what diverse things might be of historic value, from particular trees or old gardens to smithy equipment, old wells, stone walls, a carriage drive, a beloved view, a caboose, a transported station platform, or an old bunkhouse.
