**SUBJECT:** Resolution Opposing New Offshore Oil Leases in Federal Waters

# **RECOMMENDATION:**

Adopt Resolution No. 25-\_\_ entitled, "A Resolution of the City Council of the City of Goleta, California, Opposing New Offshore Oil Leases in Federal Waters."

### **BACKGROUND:**

California's central coast has long been impacted by devastating offshore oil incidents. In January and February of 1969, Union Oil's Platform A, an offshore oil facility in the Santa Barbara Channel, suffered a blowout. The spill released more than three (3) million gallons of crude oil into the Santa Barbara Channel, killing thousands of marine animals, and polluting the coastline from Goleta to Ventura and the Channel Islands, with lasting environmental and economic consequences.

On May 19, 2015, the Las Flores Pipeline System ruptured near Refugio State Beach releasing over 120,000 gallons of oil and damaging local fisheries, marine ecosystems, and coastal tourism.

Under Section 18 of the Outer Continental Shelf (OCS) Lands Act, the Secretary of the Interior is responsible for approving a schedule of OCS oil and gas lease sales for a five-year period. The Bureau of Ocean Energy Management (BOEM) is responsible for developing the National OCS Oil and Gas Leasing Program, advising the Secretary, and administering the program once adopted.

On November 20, 2025, the Secretary of the Interior announced a first analysis and proposal for the current National OCS Program, which includes six (6) lease sales along the Pacific Coast with leases set to begin in 2027. There is a 60-day comment period from November 24, 2025, to January 23, 2026, for this first analysis and proposal. There will be two more analysis and proposal periods for the proposed program before the final program is adopted by BOEM.

Meeting Date: December 16, 2025

The City of Goleta's 2025 Legislative Platform Section 5 entitled "Environmental Quality," includes a provision to oppose legislation that grants any new oil drilling, well leases, hydraulic fracturing, or any other high-intensity petroleum operations off the coast of California.

At the December 2, 2025, City Council Meeting, Councilmember Reyes-Martín sought concurrence to add a resolution opposing new offshore oil leases in federal waters to the City Council's agenda. Councilmember Kyriaco concurred with this request.

### **DISCUSSION:**

This item gives the City Council an opportunity to adopt a resolution to oppose new oil lease sales and gas activity in all offshore areas of California. If adopted by the City Council, staff will transmit a copy of the Resolution to the BOEM. See Attachment 1 for the proposed resolution.

### **FISCAL IMPACTS:**

There is no direct fiscal impact associated with transmitting this resolution other than staff time.

# **ALTERNATIVES:**

The City Council may wish to make alterations to the resolution before it is adopted or may choose not to adopt the resolution at this time.

## **RESOLUTION NO. 25-**

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLETA, CALIFORNIA, OPPOSING NEW OFFSHORE OIL LEASES IN FEDERAL WATERS

**WHEREAS,** City of Goleta residents and visitors enjoy California's beaches and the Pacific Ocean for recreational, commercial, and educational activities, all of which support our local economy; and

**WHEREAS,** our City's residents value our state's ocean and coastal waters, which provide habitat to a vast array of wildlife, including fish, whales, sea turtles, and birds that depend on a healthy and clean environment; and

**WHEREAS,** offshore oil and gas drilling and exploration off the Pacific coast puts these coastal resources, and the communities and industries that depend on them, at risk from oil spills and other damage; and

**WHEREAS**, expanding offshore oil and gas drilling and exploration threatens coastal stakeholders, marine wildlife, human health and climate; and

**WHEREAS,** a massive oil spill in 1969 off the coast of Santa Barbara fouled coastal waters and caused catastrophic economic and environmental damage; and

**WHEREAS,** in 2015 a pipeline servicing offshore oil platforms burst and fouled the same coastal areas, damaging wildlife and impacting recreational and commercial activities; and

**WHEREAS**, new federal offshore oil and gas leases have not been granted off the coast of California since 1984; and

**WHEREAS**, the state of California prohibited new oil and gas leasing in state waters due to the unacceptably high risk of damage and disruption to the marine environment; and

**WHEREAS**, opening new areas off the Pacific coast to offshore drilling will deepen the state's dependence on fossil fuels and undermine its efforts to address climate change by reducing greenhouse gas emissions and moving toward renewable energy.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLETA, AS FOLLOWS:

# SECTION 1.

The City Council of the City of Goleta joins with a broad coalition of local governments, state leaders, scientists, and residents in urging the Department of the Interior and the Bureau of Ocean Energy Management (BOEM) to exclude all areas offshore California from new oil lease sales and gas activity.

# **SECTION 2.**

The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
