SUBJECT: Authorization of OverDrive Digital Content Purchase for Library

Division in Fiscal Years 2025/26 and 2026/27

### **RECOMMENDATION:**

Authorize Library Division staff to purchase eBooks and eAudiobooks from OverDrive in the amount of \$64,000 in Fiscal Year 2025/26 and \$49,000 in Fiscal Year 2026/27 for a combined two-year total of \$113,000.

### **BACKGROUND:**

The Goleta and Santa Ynez Valley Libraries system (the "Library System") provides patrons with access to an online library of eBooks, eAudiobooks, and magazines through OverDrive, an electronic content platform that is used in over 92,000 libraries and schools worldwide. This subscription is funded through the Library System's membership in the Black Gold Cooperative Library System (Black Gold). The digital content on OverDrive is shared and available to all patrons of Black Gold libraries, in alignment with their mission: "Black Gold Cooperative Library System provides cost effective resource sharing and support, thus enabling member libraries to deliver optimal services to their respective communities."

Several Black Gold member libraries, including the Library System, have elected to set up additional collections of digital content that are purchased with each library's local funds, called OverDrive Advantage Plus accounts. These accounts provide reservation priority to patrons of the purchasing library, while also expanding the number of titles available throughout the shared Black Gold collection.

### **DISCUSSION:**

Digital collections of eBooks and eAudiobooks provide access to library resources without requiring a physical footprint. This reduced demand on physical space has been especially critical during the closure of Goleta Valley Library (GVL) for maintenance, and the operation of the smaller GVL Express location.

GVL Express houses approximately 20% of the main library's collection. Staff anticipated reduced access to the physical collection and developed a two-year budgetary strategy to mitigate the impacts on patrons both locally and Cooperative-wide by increasing access to digital content. As such there is a sharp increase for FY 2025/26 and then a significant decrease for FY 2026/27 as the construction at GVL is expected to be completed in early 2027.

Per § 3.05.040 of the City of Goleta Municipal Code, "Methods of Purchasing and Exceptions," eBooks are exempt from the competitive bid process. Attachment 3 includes confirmation of Goleta's enrollment in OverDrive Advantage Plus, which specifically allows for sharing of OverDrive Advantage purchases titles throughout Black Gold. Staff received confirmation from the City Attorney's Office that the two-year quotes (Attachments 1 and 2) and the existing OverDrive Advantage Enrollment Form (Attachment 3) serve as adequate contractual documentation for this annual purchase model.

Funding for this purpose is included in the adopted operating budgets for Fiscal Year (FY) 2025/26 and 2026/27, which include a reallocation of existing collection funds to support expanded digital collection access through OverDrive Advantage Plus and are further described in the Fiscal Impacts section.

Staff request that Council authorize the purchase of eBooks and eAudiobooks from OverDrive Advantage Plus to provide increased patron access to information and resources during the construction project at GVL.

### **FISCAL IMPACTS:**

There are no new fiscal impacts associated with this authorization. The funding allocations were approved by Council at the June 17, 2025, meeting as part of the "Adoption of the City of Goleta Operating Budget and Capital Improvement Program Budget for FY 2025/26 and 2026/27 and Five-Year Capital Improvement Program." With Council authorization, staff would expend the budgeted funds by the close of each corresponding fiscal year. The funding changes during this period are provided in the following table.

The budgeted amount for OverDrive Advantage Plus is \$64,000 in FY 2025/26 (Attachment 1) and \$49,000 in FY 2026/27 (Attachment 2), for a combined total of \$113,000.

### **ALTERNATIVES:**

Council could decline authorization of this purchase, which would result in decreased collection access throughout Black Gold and subsequent impacts to information and literacy resources in the community. It would also result in \$113,000 in unexpended budgeted funds over the next two fiscal years.

- Custom collections for your library within the shared collection website. OverDrive Advantage is a program that enables members of OverDrive-powered shared collections or consortia to add a custom collection exclusively for their patrons. These individual libraries, upon enrolling in OverDrive Advantage, may purchase digital titles in formats that their shared collection supports (e.g., audiobooks, eBooks, music and/or video) and make them available to their patrons within their shared collection's OverDrive-powered "virtual branch" website.
