The CHC advocates for housing available to households earning 120-200% of the community Area Median Income (AMI). We believe that the lack of available, affordable housing near jobs is adversely affecting our region's economy, environment, and civic life, all of which will worsen if we don't address this crucial problem.

The CHC supports the City's expeditious advancement of the Housing Element 2023-2031 program implementations to not only meet the City's obligations to HCD but to implement processes, policies and regulations helping to improve the availability of workforce housing along the South Coast.

We have reviewed Agenda Items B.2 and B.3 which both include a plethora of prioritizations. In general, we encourage your Commission to pursue the Staff Recommendations for B.2 and B.3.

Please read my comments in the public hearing. Thank you.

Dear Commissioner -

I will summarize my statement with a few sentences. I urge you not to make any recommendation until the City seeks an experienced legal opinion on whether such a policy is legal. I have.

As a matter of record, I state the following:

The staff report, and the existing inclusive housing policy, are illegal, not achievable, not reasonable, not feasible, and not acceptable. The policy is prejudicial, which leads to discrimination, it is an act of taking, and extortion, which in each case is unlawful. It discourages me after struggling for 48 years with the county and the city from building housing mandated by the State of California.

There is not a single law in the State of California that mandates a developer to provide low-income housing, and certainly Charity is not a law, therefore not enforceable.

The consultant report directly and indirectly supports my statement above. Contrary to the consultant's report, the city staff dismisses the professional finding of the export.

Perhaps after all the thousands of our tax dollars the city spends on a consultant, you should directly question the consultant and learn how different and malicious the staff's ideology and ulterior motives are. I believe the city staff dismissed the most important consultant's findings because the recommendation didn't serve their political agenda. They dismissed the report of a professional consultant.

You should understand the illegality of the low-income housing program. The City cannot simply dump the burden of inclusionary housing on <u>only one group of people</u>.

If you believe the low-income households contribute to the community, so they deserve to purchase a house below market rate with the expense of a property owner, think again. The low-income household contributes to everyone in the community, not just the property owners. It is discrimination to force this program on only the property owners. Therefore, everyone in the community as well as people who work for the cities should take 20% of their assets and income and give it to a low-income housing program. If the City is genuine about achieving affordable housing in Goleta, funding mechanisms should be pursued to create such opportunities. Raise taxes so everyone is contributing.

Furthermore, the state, and the city's regulations, rules, policies, and the NIMBs created the high cost of housing. The same house in another state cost less than 1/3 the price compared to California. As a result, inclusionary policies make developing housing projects virtually unachievable as the consultant's report demonstrates. In California, there are only 26 cities that have decided to participate in the low-income housing program, 74% have opted out.

I have never built any houses in my life, so why are you blaming me? Several times the city of Goleta discriminated against me. enough is enough. Besides, the city policy being illegal, I can not afford to go forward with your low-income housing program. Leave me out of it.
