SUBJECT: Letters of Support for the Protect Patriot Parents Act

RECOMMENDATION:

Authorize the transmission of letters of support for H.R. 3529, the Protect Patriot Parents Act, from the City Council to the Honorable Salud Carbajal, U.S. House of Representatives, the Honorable Jim Jordan, Chair of the U.S. House of Representatives Committee of the Judiciary, and the Honorable Jamie Raskin, Ranking Member of the U.S. House of Representatives Committee of the Judiciary.

BACKGROUND:

Juana Flores is a Goleta resident who first came to the United States (U.S.) without a visa in 1988 at 25 years old to raise her family, including her son, who serves in the U.S. Air Force. Since that time, Ms. Flores received several extensions to stay on humanitarian grounds and has tried to obtain permission to stay in the U.S. but was ordered to be deported in 2019. Ms. Flores left voluntarily on her own to comply with U.S. Immigration and Customs Enforcement's (ICE) order. On June 4, 2019, Judge Frank Ochoa, along with the family of Juana Flores, attended the City Council meeting and spoke under public comment about her case and her extensive Goleta/Santa Barbara-based U.S. family, including her U.S. citizen husband, ten (10) children, and fifteen (15) grandchildren at the time. At that meeting, then-Mayor Pro Tempore Richards and Councilmember Kyriaco requested that staff prepare a report and letters of support for Council consideration.

At the June 18, 2019, City Council meeting, the Council authorized letters of support for H.R.1871, the Protect Patriot Parents Act, and a letter requesting that ICE reconsider and vacate the removal and deportation order for Juana Flores and allow her to return home. The Protect Patriot Parents Act (Act) was introduced by Representative Salud Carbajal, who represents California's 24th Congressional District, including Goleta. The Act would make parents of U.S. military servicemembers eligible for Lawful Permanent Resident status, preventing potential deportations or separations of military families. The Act did not pass the House Judiciary Committee stage, and Representative Carbajal has

continued to reintroduce the Act for consideration. Most recently, Representative Carbajal reintroduced the Act as H.R. 3529 on May 21, 2025. The Act is currently referred to the House Judiciary Committee.

In 2021, Ms. Flores returned to Santa Barbara County and was granted humanitarian parole for three years. The application for an extension filed in 2024 was denied. Ms. Flores was ordered to meet with immigration authorities for a check-in. On November 27, 2025 (Thanksgiving Day) after attending this check-in in Santa Maria, Ms. Flores was deported by the U.S. Department of Homeland Security.

At the December 2, 2025, City Council meeting, Councilmember Kyriaco requested concurrence to send additional letters in support of the Protect Patriot Parents Act and in support of other legislation undertaken by Representative Carbajal regarding Juana Flores' case. The Mayor Pro Temp Kasdin and Councilmember Reyes-Martín concurred with this request.

DISCUSSION:

This item gives the City Council an opportunity to authorize letters of support for H.R. 3529, the Protect Patriot Parents Act. See Attachment 1 for the Letters of Support.

FISCAL IMPACTS:

There is no direct fiscal impact associated with acting to authorize these letters other than staff time.

ALTERNATIVES:

The City Council may wish to make alterations to the letters before they are authorized or may choose not to authorize sending the letters at this time.
