SUBJECT: Authority to Sign Estate Documents and Approval of Donation

RECOMMENDATION:

A. Authorize the City Manager or Designee to execute estate documents related to the Acceptance and Approval of Accounting and Release of Trustee for the Laura Vondracek Living Trust; and

B. Authorize the City Manager to accept a donation, currently estimated at approximately \$156,709.19 from the Laura Vondracek Living Trust for the Goleta Valley Library through approval of the Donation Acceptance Form and authorization to sign any necessary or incidental documents thereto.

DISCUSSION:

The Goleta Valley Library was listed as a residual beneficiary from the Laura Vondracek Living Trust, entitled to 10 percent of the trust estate remaining for distribution following the death of Laura Vondracek. The Trustee of the estate has reached out requesting that the City, as a beneficiary of the estate, sign an "Approval of Accounting and Release of Trustee" (the "Approval and Release").

By approving and signing the Approval of Accounting and Release of Trustee (Approval and Release), the City agrees with the accounting methods of the Trustee and the final distribution amount of approximately \$156,709.19 from the estate. Additionally, signing the Approval and Release represents that the City approves of the actions of the Trustee while administering the Trust from and after September 25, 2023, through August 31, 2024, the accounting contained within that document (see Attachment 1, page 3), and releases the Trustee for any liability regarding the Trustee's administration of the Trust during the accounting period.

The Trustee has noted that it will retain a reserve of \$40,000 for certain administrative expenses, as shown below:

1. Additional Trustee compensation of \$16,600 relating to the sale of Settlor's personal residence (1 % of gross selling price of \$1,660.00);

- 2. Additional Trustee compensation of \$4,000, relating to the disposition of two storage units located in New York containing personal effects of the Settlor as Settlor resided in New York for many years prior to moving to California;
- 3. Additional accounting fees of approximately \$2,000 relating to the preparation of two sets of federal and state income tax returns (a fee of \$15,026 having been paid to the accountant after the closing date of the Accounting, for the preparation of the Accounting and other miscellaneous accounting matters);
- 4. Additional cost reimbursements not to exceed \$5,400 for costs associated with making the final distribution of the trust estate and for payment of any unanticipated expenses that might occur prior to distribution and which are not listed herein; and
- 5. Additional attorney's fees of an undetermined amount (but not to exceed \$12,000) relating to the preparation of this Approval and Release and services relating to the final distribution of the trust estate.

Any unused portion of the reserve as shown on a supplementary closing cash statement shall be distributed equally to the residuary beneficiaries.

A beneficiary may petition the Santa Barbara County Superior Court, pursuant to California Probate Code Section 17200, to obtain a court review of the Accounting and the acts of the Trustee. If the City does not authorize the Approval and Release, the Trustee would need to obtain an order from the court under California Probate Code Section 17200(b)(5), resulting in additional time and administrative cost.

Staff has reviewed the accounting of the Trustee, finds it accurate, and recommends that the City sign the Approval and Release to allow the final distribution to occur. Due to the monetary amount of the donation, exceeding \$10,000, a formal acceptance from City Council is required to accept the Donation in accordance with the City of Goleta Donation and Gift Policy.

FISCAL IMPACTS

Once the donation monies are received, staff will request a budget appropriation in furtherance of the Goleta Valley Library renovation to complement the CA State Library Grant funding..

ALTERNATIVES:

Council may choose to not authorize the execution of the Approval and Release, which would delay the final distribution of the assets of the estate and add administrative cost. However, the City would be able to seek court review of the Trustee's accounting, if deemed necessary.

I am communicating with you as the attorney for Diane Goldsmith in her capacity as Trustee of the Laura Vondracek Living Trust ("Trust"). Enclosed for your review is an Approval of Accounting and Release of Trustee, to which an Accounting detailing the transactions of the Trustee since she became Trustee on September 25, 2023 through August 31, 2024, is attached.

Pursuant to the California Probate Code, beneficiaries of a trust are entitled to receive an accounting from the Trustee containing the following information:

- 1. Receipts and disbursements of principal and income that have occurred during the accounting period.
- 2. Assets and liabilities of the trust as of the beginning of the accounting period and as of the end of the period covered by the accounting.

The Trustee is also required to notify you that a beneficiary is entitled under California Probate Code Section 17200 to petition the court to obtain a court review of the accountings and of the acts of a trustee. Claims against a trustee for breach of trust may not be made after expiration of three years from the date you receive the accountings disclosing facts giving rise to the claim. (See California Probate Code Section 16061.)

It is the intent of the Trustee that the enclosed Accounting provide you with the same information an accounting filed with the court would disclose. Accordingly, the Trustee does not intend to have a petition prepared in order to file this Accounting with the court for approval by the court, if you agree to approve the enclosed Accounting, agree to waive the three year statutory period described above, and agree to release the Trustee for all matters disclosed in the Accounting. In this way final distribution can be made sooner and without the expense of a court proceeding.

If you agree with this course of action, please date and sign the enclosed Approval of Accounting and Release of Trustee on page 5 where indicated. A separate signature page is enclosed for your use in returning the signed signature page to Howard M. Simon, attorney for the Trustee, at Jarvis, Hartloff & Simon, PO Box 1479, Santa Barbara, CA 93102. Please also scan and email a copy of the signed signature page to hsimon@jhslawsb.com. Upon receiving the signature page from all

APPROVAL OF ACCOUNTING

AND

RELEASE OF TRUSTEE

The Laura Vondracek Living Trust

I. <u>INTRODUCTION</u>

As a result of the death of Settlor Laura Vondracek on September 25, 2023, the Laura Vondracek Living Trust dated November 4, 2011, as restated by Restated Amendment dated August 20, 2020, and as interpreted by Order of the Superior court of the State of California for the County of Santa Barbara Instructing Trustee Re Validity of Handwritten Changes to Distribution Provisions filed by the Court of May 8, 2024, (hereafter the "Trust") terminated.

Pursuant to the provisions of the Trust, Diane Goldsmith became Trustee of the Trust as of the date of death of the Settlor, and she is the currently acting Trustee of the Trust.

Pursuant to the Court Order referenced above, the Court determined that the trust estate is to be distributed in equal shares to the following residuary beneficiaries of the Trust (hereinafter "residuary beneficiaries"): Santa Barbara Channel Keeper, Central Park Conservancy (New York City), Heal the Ocean (Santa Barbara), Food Bank of Santa Barbara, Environmental Defense Center (Santa Barbara), Planned Parenthood Federation of America, ACLU Foundation, Sea Shepherd Global, Goleta Library, and the New York Public Library. Accordingly, each residuary beneficiary is entitled to a distribution of ten percent (10%) of the trust estate remaining for distribution.

Based on the value of the assets on hand at the end of the Accounting period as described in Paragraph II of \$1,622,117.92, and subject to the total of the expenditures that have occurred after the date of the Accounting, and the reserve, of \$55,026 as described in Paragraph III, each residuary beneficiary will receive a distribution of approximately \$156,709.19 if this Approval of Accounting and Release of Trustee (hereinafter "Approval and Release") is agreed to by the residuary beneficiaries, and additional fees and costs for a court approval of the accounting thereby avoided.

This Approval and Release is being submitted to the residuary beneficiaries to obtain each residuary beneficiary's approval of the actions of the Trustee in administering the Trust from and after September 25, 2023, through August 31, 2024, as reflected Accounting described below, and to obtain each residuary beneficiary's release of any liability for the Trustee's administration of the Trust for the period of the Accounting.

II. ACCOUNTING

- A. The Trustee has delivered with this Approval and Release, to each residuary beneficiary, an Accounting covering the period of September 25, 2023 through August 31, 2024, detailing the activities of the Trustee during said period. An attachment to the Accounting details the reimbursements made to the Trustee during said period as reflected on the Accounting.
- B. A beneficiary may petition the Santa Barbara County Superior Court pursuant to California Probate Code Section 17200 to obtain a court review of the Accounting and of the acts of the Trustee.
- C. The Trustee does not intend to present a petition to the Santa Barbara County Superior Court seeking approval of the Accounting unless the Beneficiaries do not approve the Accounting, and do not release the Trustee from liability.

III. FINAL DISTRIBUTION OF TRUST ASSETS AND RESERVE

- A. The Trustee will distribute all remaining assets of the trust estate to the residuary beneficiaries, except for a reserve described in Paragraph B. next following, upon acceptance of this Approval and Release, or upon Court approval of the Accounting filed by the Trustee should the residuary beneficiaries decide not to accept this Approval and Release.
- B. If the residuary beneficiaries accept this Approval and Release, the Trustee will retain a reserve of \$40,000 for payment of the following expenses:
 - 1. Additional Trustee compensation of \$16,600 relating to the sale of Settlor's personal residence (1% of gross selling price of \$1,660.00);
 - 2. Additional Trustee compensation of \$4,000, relating to the disposition of two storage units located in New York containing personal effects of the Settlor as Settlor resided in New York for many years prior to moving to California;
 - 3. Additional accounting fees of approximately \$2,000 relating to the preparation of two sets of federal and state income tax returns (a fee of \$15,026 having been paid to the accountant after the closing date of the Accounting, for the preparation of the Accounting and other miscellaneous accounting matters);
 - 4. Additional cost reimbursements not to exceed \$5,400 for costs associated with making the final distribution of the trust estate and for payment of any unanticipated expenses that might occur prior to distribution and which are not listed herein; and
 - 5. Additional attorney's fees of an undetermined amount (but not to exceed \$12,000) relating to the preparation of this Approval and Release and services relating to the final distribution of the trust estate.

Any unused portion of the reserve as shown on a supplementary closing cash statement shall be distributed equally to the residuary beneficiaries.

IV. APPROVAL OF ACCOUNTING

- A. By its signature herein, each residuary beneficiary approves all transactions, accounts, reports, and acts of the Trustee of the Trust for the period of the Accounting in lieu of a court accounting.
- B. Each residuary beneficiary has had the opportunity to review the Trustee's Accounting and to consult with such advisors as the beneficiary considers appropriate about that information.
- C. Each residuary beneficiary has concluded that no constructive purpose will be served by the Trustee's submission of a formal Petition to the Court for settlement and approval of an accounting.

V. RELEASE AND DISCHARGE

- A. Each residuary beneficiary releases and discharges the Trustee, individually and as Trustee, from and against any and all claims, damages, liabilities, losses and expenses of any kind, known or unknown, in connection with her administration of the Trust, for the period of the Accounting.
- B. This approval of the Accounting and the release and discharge of the Trustee by each residuary beneficiary shall have the same effect as an Order obtained under California Probate Code Section 17200(b)(5).

VI. WAIVER

Each residuary beneficiary further waives its rights to petition the Court for a judicial review of the transactions and acts of the Trustee, as to any matter or transaction reported in the Accounting.

VII. <u>CONSIDERATION</u>

The approval, release, and waiver signed by each residuary beneficiary is given as an inducement, and in exchange for, the agreement of the Trustee not to prepare a Petition and submit the Accounting to the Court for a review of the Accounting that would reflect the transactions and actions as reported therein, as that approach would increase the costs of the administration and would delay the distribution of the trust estate.

VIII. REPRESENTATIONS

A. Each residuary beneficiary has read this Approval and Release and understands its contents.

B. Each residuary beneficiary acknowledges that it has had the opportunity to be represented by legal counsel of the beneficiary's own choice, that each residuary beneficiary has obtained such legal advice as the beneficiary considered proper, and that each residuary beneficiary has executed this Approval and Release with the consent and advice of counsel, or the knowing decision to forego obtaining legal representation.

IX. CONSTRUCTION

- A. All questions with respect to the construction of this Approval and Release and the rights and liabilities of the parties shall be governed by the laws of the State of California in effect as of the date of this Release.
- B. This Approval and Release may be executed in any number of counterparts, any one of which need not contain the signatures of more than one part, but all such counterparts together will constitute one Approval and Release. Counterparts may be delivered via electronic mail (including pdf or any electronic signature complying with the U.S. Federal ESIGN Act of 2000, e.g.www.documsign.com) or other transmission method, and any counterpart so delivered shall be deemed to have been duly and validly delivered and valid and effective for all purposes.

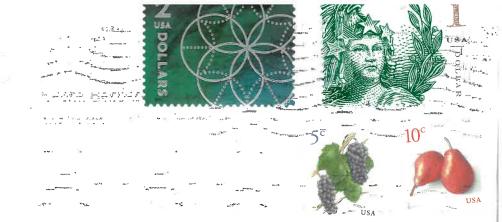
