SUBJECT:	County of Santa Barbara Presentation on 2025 Point-in-Time Count

#### **RECOMMENDATION:**

Receive a presentation by the County of Santa Barbara's Community Services Department on the results from the 2025 Point-in-Time Count.

#### BACKGROUND:

Each year, during the last ten days of January, the federal Department of Housing and Urban Development (HUD) requires communities across the country to conduct comprehensive counts of the local population experiencing homelessness. These Point-in-Time (PIT) Counts measure the prevalence of homelessness in each community and collect information about individuals and families residing in emergency shelters, transitional housing, sleeping on the streets and encampments, in vehicles, or other places not meant for human habitation at this specific point in time.

The data from the PIT is broken down by city and a host of other demographics and shared with the public in an annual report presented by the County of Santa Barbara's Community Services Department's Housing and Community Development Division.

#### **DISCUSSION:**

The results from the 2025 PIT illustrate a marked increase in homelessness for the City of Goleta, specifically for people living in vehicles. The County staff from the Housing and Community Development Division will provide a presentation with detailed analysis of both the PIT observations and ongoing efforts to end homelessness (Attachment 1).

It is important to note that, while very valuable from a trend standpoint, the PIT is a single moment's once-a-year observation of people experiencing homelessness collected by volunteers. The City of Goleta tracks the number and status of people experiencing

homelessness through both the County of Santa Barbara's Homelessness Management Information System, and a staff-generated by-name list.

## **Data Sources**

County staff consider all data sources when developing response strategies.

### Homeless Management Information System (HMIS)

- Required by the Department of Housing and Urban Development.
- Our most reliable source of real-time data.
- The Coordinated Entry System (CES) uses this system as the basis for matching and referrals to housing.
- HMIS users receive ongoing training and technical support from County staff.
- Provides a comprehensive look at system efficiencies and bottle-necks.
- Is considered the system of record for HUD data reporting.

## **Point in Time Count (PIT)**

- Required by the Department of Housing and Urban Development.
- A snapshot of homelessness on a single night during the last 10 days in January.
- When possible, information is collected by volunteers and agency staff.
  - This information is extrapolated across all observational counts.
- A great way to get the community involved and raise awareness of homelessness.
- Produces "sound bite" style data that is easily used to determine future funding levels and communicate with the public.

Key Trends in the County-wide Homelessness Response System



### Number of People Accessing Services The *known* "total homeless" HMIS



- The growth rate in the number of people accessing services has slowed year over years.
- The *total number* of people *counted as homeless* continues to rise, especially those living in vehicles.
- The number of people experiencing homelessness represents about 1% of the total County population.

### Those Newly Accessing Services vs Those Exiting to Housing HMIS



- When these lines intersect,
  our community will
  approach "functional zero,"
  or where entries equal or
  fall below exits.
  - Most of the growing subpopulation of vehicular homeless is not included here.
- The top blue line only reflects individuals who reported experiencing homelessness for the first time in the calendar year indicated – a subset of the numbers on the previous slide

## Recent Successes

#### **Encampment Response**

- Resolved 102 encampments, 100 people entering shelter, and 64 people obtaining housing.
- 151 individuals connected to services in the first 10 months of CERF 3.

#### **Two New Interim Housing Facilities**

- 359 people served, including 275 experiencing chronic homelessness.
- 56 people have achieved permanent housing.

#### **Permanent Housing**

• Buena Tierra opened its doors to permanently house 60 households in August 2024.

#### **Additional Services**

- Hedges House of Hope kitchen opening.
- It is now providing lunch and dinner for residents at local interim housing facilities – about 330 meals per day.

### **Point in Time Count Trends**

Unsheltered Vehicular Sheltered



- The number of people living sheltered increased by 61% since 2022.
- The number of people living unsheltered decreased by 25% from 2022.
- People living in their vehicles increased 42% since 2022.
- Overall, the people counted on the night of the PIT has increased 24% over the past 4 counts.
- PIT Count results should be kept in context of larger, more comprehensive data base.

## **PIT Count Geographic Distribution**

- The cities of Carpinteria, Santa Barbara, and Goleta comprise 30% of the total county population and 54% of the unhoused population.
- The City of Goleta has 7% of the total county population and 9% of the unhoused population.
- These charts include sheltered, unsheltered, and vehicular homelessness. Vehicular homelessness makes up a larger proportion of the count in South County than in North County.

Yellow Dot - Single Vehicle

#### **Goleta Observations** PIT

- There was, once again, a decrease in the number of people counted near the Camino Real Marketplace.
- There was a decrease in the number of unsheltered people in the residential area north of the 101 near Fairview, but an increase in people living in their vehicles in the same area.
- There was a decrease in unsheltered in Old Town Goleta, but an increase in vehicles in the surrounding neighborhoods.

## Point in Time Count by City

- The number of people living in their vehicles is nearly twice the number of people living outside.
- However, based on available data, people living in vehicles are not accessing the homeless service system at the same rate as people living outside.



# System Wide Data Trends





## The Housing Inventory Count

- Is conducted concurrently with the Point in Time count.
- Counts the number of beds dedicated to unhouse people.
- 106 Permanent beds were added between 2024 and 2025 (467 Permanent beds added since 2022).
- 212 Interim Housing beds were added between 2024 and 2025 (448 added since 2022).



## System-wide Data Trends

- Decrease in Veteran Homelessness (HMIS):
  - 2024 90 people
  - 2025 51 people
- Increase in Families (PIT):
  - 2024 125 households
  - 2025 146 Households
  - Many of the families counted were living in vehicles.
- Increase in Transitional Aged Youth (18-24) (PIT):
  - 2024 78 people
  - 2024 127 people







- Increase in Seniors (55+) (PIT):
  - 2024 720 (34% of those counted)
    - 2025 911 (37% of those counted) - 26% of people living in the County are over the age of 55.
- Increase in length of time a person is in the system (PIT):
  - 2024 97 days
  - 2025 133 days
    - Unhoused includes Interim Housing stays.
