#### **RECOMMENDATION:**

A. Conduct interviews for the Santa Barbara County Library Advisory Committee; and

B. Recommend to the Mayor a nominee for appointment to the County of Santa Barbara County Library Advisory Committee to represent the City of Goleta.

## **BACKGROUND:**

The Board of Supervisors created a county-wide Library Advisory Committee so that representatives of communities with libraries operating as part of the regional free library system could meet quarterly to discuss issues of mutual concern.

The Board determined that each contracting city may nominate one citizen from that community to serve as a member to the Committee. Consistent with the requirements of Government Code Section 40605, the Mayor has made this appointment, subject to the City Council's approval. In years past, terms were concurrent with the one-year term of the Agreement for Operations of a County Wide Library System, beginning on July 1 and ending June 30 of the following year.

In 2021, Section 13 of the agreement was amended to provide that the term of office of each member of the Library Advisory Committee shall annually and automatically renew each year, unless replaced at the pleasure of the Board of Supervisors or by request of the nominating jurisdiction. So, the City is no longer required to recommend a nominee annually. Staff recommends that the City of Goleta's representative's term be revisited every four years, like other City board and commissions. Following the recruitment for the new four-year term, the name of the nominee with be forwarded to the Board of Supervisors for approval, after which the Mayor will ratify the appointment with Council approval.

The Library Advisory Committee meets quarterly to review services and operations, and to make advisory recommendations to the Board of Supervisors and cities participating in the County library system. The next meeting is scheduled for December 6, 2023.

The City of Goleta appointed Cole Heimerdinger on November 15, 2022 with a term ending June 30, 2023. Mr. Heimerdinger notified staff that he would not be seeking reappointment.

#### **DISCUSSION:**

The purpose of this agenda item is to allow the City Council the opportunity to interview and nominate an appointee to the Santa Barbara County Library Advisory Committee to fill the vacant position. The City of Goleta nominee will then be considered and confirmed by the Santa Barbara County Board of Supervisors. The County Board of Supervisors' appointment will then be considered for the Council ratification of the mayoral appointment.

In anticipation of the expiring term, the City Clerk's office published requests for candidate applications on the City website, the Monarch Press, Channel 19, the local adjudicated newspaper, postings at the Goleta Valley Library, Jonny D. Wallis Park, GovDelivery Bulletins, various social media sites (Facebook, Instagram and X, formally known as Twitter) and generated press releases.

At the conclusion of interviews, each Councilmember will be asked to state a preferred nominee. The Mayor will refer a nominee to the Board of Supervisors. Ratification of the mayoral appointment will come before the City Council once the County Board of Supervisors confirms their appointment.

#### **ALTERNATIVES:**

Council is under no obligation to make an appointment at this time. However, because Heimerdinger is not available for an automatic renewed appointment, taking no action would mean that this position would remain vacant until a new appointment is made.






