#### Recommendation:

It is recommended that the Planning Commission:

1. Adopt Resolution 22-, entitled "A Resolution of the Planning Commission theCity Goleta, California, of of rescinding Planning Commission Resolutions No. 22-14and No. 22-15 Finding the Right-of-Way Exchange and Park Dedication associated with the Heritage Ridge Development Project Conforms with the City'sGeneral Plan pursuant to Government Code Section 65402, including the associated CEQA finding that the Actions are Categorically Exempt under CEQA, and Finding that the Rescission is not a Project under the California Environmental Quality Act (CEQA)." After the Environmental Impact Report ("EIR") pertaining to the Project is certified and the conditions related to the property dedication are near satisfaction, the resolutions finding that the Right-of-Way Exchange and Park Dedication associated with the Heritage Ridge Development Project conforms with the City's General Plan pursuant to Government Code Section 65402, be brought back for the Commission's consideration.

3. Direct the City Attorney to execute and the City Clerk to send a letter to SWRCC conveying that the Planning Commission considered its response to SWRCC's demand for a cure or correction in its November 14, 202 letter and conveying that the Planning Commission has taken the actions described above.
