SUBJECT: Interviews of Candidates for the Public Engagement Commission, Planning Commission and the Mosquito and Vector Management District Board of Santa Barbara County

RECOMMENDATION:

- A. Conduct candidate interviews for the Public Engagement Commission, Planning Commission and the Mosquito and Vector Management District Board of Santa Barbara County; and
- B. Select four nominees for the Public Engagement Commission Mayoral Appointment; and
- C. Select one nominee for the Mosquito and Vector Management District Board of Santa Barbara County; and
- D. Continue this item to the December 21, 2021, City Council meeting for the four Mayoral Appointments to the Public Engagement Commission, one Mayoral Appointment to the Planning Commission and one Mayoral Appointment to the Mosquito and Vector Management District Board of Santa Barbara County.

BACKGROUND:

Public Engagement Commission

On May 16, 2017, Council adopted Resolution No. 17-18 establishing the City's Public Engagement (PEC) Commission, consisting of seven members. In September 2018, Council amended the Commission makeup to include a youth member. The terms for the PEC were initially established in 2017 on a staggered model, similar to other boards and commissions. On September 11, 2017, four seats, including the Goleta District Elections Committee member, were appointed to four-year terms that expired on November 1, 2021.

Staff received applications from Rey Ybarra (Goleta Elections Committee Appointee) and Pedro Paz and Silvia Uribe to be considered for re-appointment to the Public Engagement Commission. Staff has also received applications from Susan Klein- Rothschild and Irene Solovij for consideration.

Planning Commission

The Planning Commission is authorized by Goleta Municipal Code Section 2.09.010. The Planning Commission consists of five members, each of whom must be a resident of the City of Goleta and a qualified elector within the City. The term of office for each Commissioner is four years and is set to expire at the first regular meeting in February.

Pursuant to California Government Code Section 4605, all appointments to the City's boards and commissions, including the Planning Commission, must be made by the Mayor and approved by the City Council. Per Goleta Municipal Code Section 2.15.040 (C), at the conclusion of all interviews for positions to the Planning Commission, each Councilmember elected or re-elected to office in the immediately preceding election shall announce one preferred candidate, and the City Clerk shall compile a list of candidates for each vacancy based on the designated Councilmembers' selections.

In the event of an unscheduled vacancy on the Planning Commission, only the Councilmember who suggested the vacating Commissioner's candidacy shall announce a preferred candidate for appointment by the Mayor.

One Planning Commissioner, Alfred Smith, recently resigned from their appointment prior to the expiration of their term. They were the preferred candidates of Councilmember Aceves. As such, following interviews of applicants in serving on the Planning Commission, Councilmember Aceves will announce one preferred candidate for appointment to the remaining term of the resigning Commissioner, which will expire on February 1, 2023.

Staff received applications from Brad Blue and Elrawd Maclearn for consideration to the Planning Commission.

Mosquito and Vector Management District Board Santa Barbara County

The District is governed by an eight-member Board of Trustees; three trustees are appointed by the City Councils located within the benefit assessment areas—Goleta, Santa Barbara, and Carpinteria—and five trustees are appointed by the County of Santa Barbara's Board of Supervisors. The District's Board of Trustees meets on the second Thursday of each month via Zoom at 2:00 PM, to discuss District business and authorize fiscal and operational activity. Appointments are for a two-year term. Craig Geyer, initially appointed by the City Council February 2016, reappointed in January 2018, and January 2020 has expressed interest in remaining on the Mosquito and Vector Management District Board beyond the current term ending in January 2022.

DISCUSSION:

In anticipation of the expiring terms for the Public Engagement Commission, and the Mosquito and Vector Management District Board Santa Barbara County, and the unanticipated vacancy on the Planning Commission, the City Clerk's office published requests for candidate applications on the City website, the Monarch Press, Channel 19, the local adjudicated newspaper, Facebook, GovDelivery Bulletins, Twitter, and generated press releases.

Public Engagement Commission

There are three regular vacancies on the Public Engagement Commission and one Goleta Elections Committee Appointee vacancy, all for four-year terms. Staff has confirmed the following interview times for these Public Engagement Commission Applicants.
