Dear Members of the City of Goleta Design Review Board and Ms. Mary Chang:

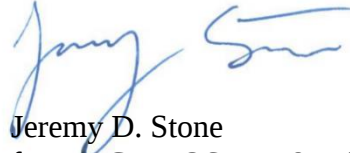
