SUBJECT: Magnolia Avenue Sidewalk Infill Project (9082) Notice of Completion

RECOMMENDATION:

A. Adopt Resolution No. 18-___ entitled "A Resolution of the City Council of the City of Goleta, California, Authorizing the Filing of a Notice of Completion for the Magnolia Avenue Sidewalk Infill Project (9082);" and

B. Direct the City Clerk to file a Notice of Completion.

BACKGROUND:

On August 15, 2017, Council awarded a construction contract (Agreement 2017-067) for the Magnolia Avenue Sidewalk Infill project (9082) to JJ Fisher Construction, Inc. in the total amount not to exceed of \$216,020, with a contingency for change orders in the amount of \$21,600. This report summarizes construction work and costs associated with the project.

On August 15, 2017, Council approved and executed Agreement 2017-068 with MNS Engineers, Inc. (MNS) for Construction Management, Inspection and Testing (CMIT) services for a total not to exceed \$38,504.

DISCUSSION:

Staff issued JJ Fisher Construction, Inc. (JJ Fisher) a Notice to Proceed on September 18, 2017. The work consisted of constructing approximately 600 linear feet of sidewalk on the east and west sides of Magnolia Avenue from Hollister Avenue south to Gaviota Street. The work also included replacing driveways, curb and gutter, four Americans with Disabilities Act (ADA) access ramps, removing three trees and planting five trees. The Project was necessary to replace deteriorated sidewalk in some areas and other areas where the sidewalk was paved with asphalt with no curb and gutter.

Meeting Date: April 17, 2018

JJ Fisher substantially completed the project on November 20, 2017, and over the next few months, staff worked with JJ Fisher to finalize construction invoices and complete project closeout activities.

Staff is recommending adoption of the proposed resolution to facilitate the final closeout of this project (Attachment 1). A Notice of Completion pursuant to Public Contract Code §20854 is recommended for approval and direction to be filed with the County of Santa Barbara, County Recorder Office (Attachment 2).

FISCAL IMPACTS:

The construction, contingency, and CMIT costs were estimated to be \$276,124. The actual cost for construction, including quantity changes, contingencies, and construction management, totaled \$269,578, which was within budget. There were two change orders for construction extra work for a total of \$2,853. The extra work included providing two signs stating, "Businesses Are Open During Construction" and temporarily covering, removing, hauling and properly disposing of non-hazardous contaminated soils. The project was entirely funded by Measure A and Community Development Block Grant (CDBG) funds.

The final expenditure worksheet for the project, including construction and CMIT is shown in the table below:
