SUBJECT: Public Hearing for Approval of 2018-19 Community Development Block

Grant (CDBG) Action Plan

#### **RECOMMENDATION:**

A. Conduct a public hearing to receive input on the needs, goals and objectives identified in the 2018-19 Community Development Block Grant (CDBG) Action Plan, which has been updated to reflect the 2018-19 funding allocation received from the U.S. Department of Housing and Urban Development (HUD).

B. Approve the final 2018-19 CDBG Action Plan and authorize submittal to HUD, subject to staff making any edits requested by the City Council.

#### **BACKGROUND:**

The City receives an annual allocation of Community Development Block Grant (CDBG) funding from the U.S. Department of Housing and Urban Development (HUD). The primary objective of the CDBG program is the development of viable communities, decent and affordable housing, and expanded economic development opportunities for persons of very low, low and moderate incomes. As a CDBG entitlement community, the City of Goleta is required to submit an annual Action Plan to HUD. The Action Plan articulates the City's proposed CDBG programs and projects for the upcoming program year, sets annual goals, and indicates how the CDBG funding will be allocated.

On December 21, 2017, the City published a Notice of Funding Availability (in English and Spanish), inviting applications for Fiscal Year (FY) 2018-19 funding through both the Goleta City Grant Program and the CDBG program. Outreach for FY 2018-19 grant funding was provided via a press release, newspaper advertisement, the City's website and direct notification to former applicants. The deadline for receipt of grant applications was January 31, 2018. Of the 51 applications received altogether, one applicant rescinded their application. Of the 50 remaining applications, 9 applicants requested funding through the CDBG program in the area of programs and services. Applications

for CDBG covered services for youth, seniors, the homeless, and other miscellaneous programs for low-income residents.

The 9 CDBG programs and services applications were considered by the Standing Grant Funding Review Committee (Committee) on March 7, 2018. Then, at a second meeting on March 29, staff provided the Committee with a brief overview of the capital projects proposed to be funded through the CDBG program in 2018-19. The Committee's recommendations for programs and services and capital projects funding were then presented to City Council on April 3, 2018. At that time, the City had not yet received its 2018-19 CDBG funding allocation from HUD, so staff used an estimate of \$173,650 in total funding (slightly less than what was received FY 2017-18). The City Council accepted the recommendations of the Committee for incorporation into the Draft 2018-19 CDBG Action Plan. These recommendations included \$34,730 for planning and administration, \$26,000 for public services; and \$112,920 for capital projects; of the \$112,920 for capital projects, approximately \$103,000 was proposed to be spent on a Midblock Crosswalk at Kellogg Avenue, with remaining funds (\$9,920) to go towards needed disabled access improvements at the Goleta Valley Community Center (Community Center). Both proposed capital projects are located in Old Town Goleta. which contains the City's largest concentration of low-to-moderate income residents and meets HUD's requirement to fund projects that are a designated area-benefit activity.

Overall, the City's needs, priorities and potential projects for 2018-19 were developed in consideration of the goals that were established in the 2015-19 Consolidated Plan adopted by the City Council on May 6, 2014. The services and programs included with the 2018-19 Action Plan cover assistance to homeless persons, provision of health care services to low-income persons, and provision of essential resources for low-income families (e.g. educational, recreational, and social programs for children and their families). The Draft 2018-19 Action Plan was reflective of the priorities and goals of the Consolidated Plan, both in terms of providing a variety of needed public services to the homeless and low-income individuals, and also through construction of needed public infrastructure in Old Town Goleta.

A 30-day public review period was conducted for the Draft Action Plan from April 5, 2018 through May 5, 2018. The City received its funding allocation from HUD on May 1, 2018 totaling \$216,359, which amounts to \$42,709 more than originally estimated. The City's HUD representative informed staff that it would allow an extension of the initial May 15, 2018 deadline for Action Plan submittal, to give the City a chance to update the document with corrected funding amounts. As such, the City has prepared an updated Action Plan that reflects the funding award received from HUD, which consists of \$43,272 for planning and administration (20% of grant total), \$32,454 for public services (15% of grant total); and \$140,633 for capital projects (65% of grant total). The updated document is included as Attachment 1 to this report. Prior to updating the Draft Action Plan, the Committee met on May 24, 2018 to discuss how to allocate the additional funding available for the programs and services and capital projects. The table in the following section summarizes the changes proposed by the Committee to the original estimates; these proposed changes are reflected in the updated Action Plan.

This is the second of two public hearings conducted for the CDBG Action Plan, which is in accordance with the City's CDBG Citizen Participation Plan. The first hearing occurred on April 3rd. Comments received from both hearings will be incorporated into the final Action Plan that gets submitted to HUD.

#### DISCUSSION:

The complete list of funding recommended by the Committee and included with the updated Draft 2018-19 CDBG Action Plan is summarized in the below table. It should be noted that two of the proposed grant subrecipients - Community Action Commission and Girls Inc. - had originally been recommended to receive funding under the City Grant Program in the amount of \$4,000 each. However, the Committee has recommended moving these applicants to instead receive funding under the CDBG program. The recommended funding awards for each applicant were consequently increased to \$5,000 each, to meet the required minimum award amount for this grant. The Committee agreed that both of these subrecipients' programs would be a good fit for the CDBG program; furthermore, both applicants had originally requested funding through CDBG.

\*The New Beginnings Counseling Center was originally recommended by the Committee and approved by City Council for \$7,000 in CDBG funding. This subrecipient's award is now proposed to be split between CDBG and the City Grant Program; the grant award still totals \$7,000.

In the area of capital projects, the Grant Funding Review Committee is recommending applying all of the CDBG capital funds (\$140,633) to the Midblock Crosswalk at Kellogg Avenue (Midblock Crosswalk). Previously, \$103,000 was proposed for this project, with any remaining funds dedicated to completing disabled access improvements at the Community Center. The Committee's recommendation to expend capital funding solely on the Midblock Crosswalk was based on the following considerations that were presented by staff at the Committee meeting on May 24, 2018:

 The alternative of dividing the CDBG capital funds between two projects, with most of that funding allocated to the Midblock Crosswalk, would leave only a

small portion of funds available to be expended at the Community Center. To make the Community Center improvements more cost effective and part of a larger and more comprehensive project, staff and the Committee are instead recommending that the Community Center improvements get prioritized in the 2019-20 CDBG program year. In this case, all CDBG capital funds received in 2019-20 would be dedicated to addressing the various disabled access and other improvements identified in the 2010 Facilities Reserve Study completed for the Community Center.

- The \$103,000 originally budgeted by staff for the Midblock Crosswalk at Kellogg Avenue was an estimate to cover construction-only. There were no funds, CDBG or otherwise, budgeted by the City to pay for a construction management consultant or staff time on this project. Now in consideration of the larger-thanexpected capital allocation from HUD, CDBG is a viable source to pay for these costs.
- There is an existing construction element included with the Hollister Kellogg Park project that the Committee recommends be constructed as part of the Midblock Crosswalk instead. This element is the installation of electrical conduit across Kellogg Avenue in the vicinity of where the crosswalk will be located; the electrical is for a nearby streetlight and not the flashing beacons associated with the crosswalk. However, because that improvement will occur in the construction area of the crosswalk, staff and the Committee recommend that it be included as part of the crosswalk's scope of work and paid for using the CDBG capital improvement funds.

In summary, these additional identified costs for the Midblock Crosswalk at Kellogg Avenue are recommended to utilize all the 2018-19 available capital funding (\$140,633), while the Community Center improvements are recommended to be prioritized in the 2019-20 CDBG program year. At the time of this report's publishing, Public Works staff were still finalizing a detailed cost breakdown for the Midblock Crosswalk. Staff will present these cost details during the public hearing on June 5, 2018.

#### **FISCAL IMPACTS:**

For FY 2018-19, the City's CDBG total allocation from HUD is \$213,650, which is an overall increase of \$42,709 from the original estimate of \$173,650. The revised FY 2018-19 budget includes this update, and has been adjusted accordingly.

#### **ALTERNATIVES:**

City Council may direct staff to make changes to any of the goals, objectives, and funding amounts included in the 2018-19 Action Plan (Attachment 1). Any changes would be incorporated into the final Action Plan that is required to be submitted to HUD following this public hearing. City Council could decide not to approve the 2018-19 Action Plan, which would put the City in jeopardy of meeting HUD's required deadline for Action Plan submission. The final regulatory deadline for submission is August 15, 2018, after which point the City would have no recourse for receiving its allocation in the event the Action Plan is not submitted by this time. Staff do not recommend putting off

submittal of the document any longer than needed, so as not to put the City at risk of losing its allocation and impacting all of the various programs, services, and projects proposed for funding through this grant.

## **Executive Summary**

#### 1. Introduction

This Action Plan outlines the City's CDBG activities for the 12-month period from July 1, 2018 to June 30, 2019. As with all CDBG activities, the projects outlined in this Plan must meet one of the United Stated Department of Housing and Urban Development's (HUD's) three national objectives for the CDBG program. These objectives include:

- Activities which benefit low- and moderate-income persons;
- Activities which aid in the prevention or elimination of slums or blight; and
- Activities designed to meet community development needs having a particular urgency.

The City's 2018 Action Plan goals concentrate efforts on the first national objective - activities which will benefit low- to moderate-income people who reside in the City of Goleta. The City's 2018-2019 proposed projects and activities also support the needs and priorities identified in the City's 2014-2019 Consolidated Plan. The Consolidated Plan is a community blueprint for meeting the housing and community development needs of the City of Goleta. The Consolidated Plan provides a description of existing housing and community development needs, and long-term strategies to address those needs.

#### 2. Summarize the objectives and outcomes identified in the Plan

The City is committed to allocating CDBG funds to serve the needs of low-income residents of the City of Goleta. Goleta has identified special-needs individuals as among those who face the greatest challenges and who should receive high priority in the expenditure of federal funds, including at-risk children and youth, low-income families, the homeless and persons at-risk of becoming homeless, and the elderly (especially frail elderly). Priorities can be achieved through a combination of 1) decent and affordable housing; 2) investment in public infrastructure in targeted lower-income and deteriorating neighborhoods, and in facilities that serve lower-income and/or special needs populations; and 3) public services to low- to moderate-income people, including, but not limited to health care, food and nutrition programs, educational programs, activities and support for seniors, housing assistance, job training and case management and counseling for the homeless, enrichment programs for youth, and

Annual Action Plan 2018 medical programs for low-income people. Capital projects funded in part with CDBG funds are typically located in Old Town Goleta and Census Tract 30.01 where the City's largest percentage of low- to moderate income people reside. Capital projects for Program Year 2018-2019 are concentrated on pedestrian improvements within Census Tract 30.01.

#### 3. Evaluation of past performance

<span style="color: black; line-height: 115%; font-family: 'Arial', 'sansserif'; font-size: 12pt;">The City is making progress on the priorities addressing the needs identified and described in its 2015-2019 Consolidated Plan. The City is in its fourth year of Consolidated Plan implementation, and most objectives are on target. The City's greatest challenges are retaining and expanding its stock of affordable housing with the continued high cost of housing and the lack of undeveloped land within the City. Although the City continues to look for opportunities to facilitate the development of affordable housing, the factors of high housing costs and the lack of undeveloped land have an impact on the fulfillment of the City's overall goal of developing viable communities through the provision of decent housing, a suitable living environment and expanded economic opportunities for principally low and moderate income persons. However, the City has continued to make big strides in assisting low- to- moderate-income people through its CDBG public service funding.

#### 4. Summary of Citizen Participation Process and consultation process

On May 5, 2009, the City adopted an updated Citizen Participation Plan (CPP) as part of an amendment to its 2008-2009 Action Plan.   Barbara News-Press on December 21, 2017, was posted on the City's website, and was emailed
  to interested social service providers.
- A public notice requesting comments from citizens and agencies about the City's CDBG funding allocations, and housing and community development needs and priorities for the 2018-2019 program year was published in English and Spanish in the Santa Barbara Independent on March 22, 2018. This notice also informed the public about a public hearing held on April 3, 2018, for the purpose of receiving comments on these topics.

- A public hearing to receive comments from citizens and agencies about the City's CDBG funding allocations, and housing and community development needs and priorities for the 2018-2019 program year was held before the City Council on April 3, 2018.
- A 30-day public review period on the Draft 2018-2019 Action Plan was conducted from April 5, 2018, to May 5, 2018. This public review period was extended after the City received its 2018-2019 CDBG funding allocation from HUD.
- Public comments received during the 30-day public review period which was extended to allow
  the community an opportunity to review and comment on the updated funding allocation
  amounts received from HUD, will be shared with City Council on June 5, 2018. On this same
  date, the final 2018-2019 Action Plan will be approved for submittal to HUD.

The Santa Barbara County Housing and Community Development Department (HCD) is the lead agency responsible for the application to HUD's Continuum of Care (CoC) Homeless Assistance Program. HCD identifies gaps in homeless program funding and applies to HUD for CoC funds annually for new and renewing projects based on local needs and priorities. The City of Goleta is within the Santa Maria/Santa Barbara County CoC. Homeless persons or those in danger of becoming homeless are also served by the South Coast Homeless Prevention and Rapid Re-Housing Program (HPRP).

The Homeless Prevention and Rapid Re-housing Program (HPRP) is a collaboration between the Central Coast Collaborative on Homelessness (transitioning to Home for Good Santa Barbara County), Casa Esperanza, Catholic Charities, Legal Aid Foundation, Transition House, Rental Housing Mediation Task Force, Family Service Agency, and the City and County of Santa Barbara. The services offered include help locating housing; financial assistance for rent due, security deposits, utilities and moving costs; help with locating housing; legal aid to inform people of their rights; and mediation to help prevent evictions.

Annual Action Plan 2018 The services are available to people who have an income of 50% or less than the Area Median Income, and are at risk of becoming homeless, or are currently homeless.

The City of Goleta also includes funding, both CDBG and typically City General Fund money, for homeless programs on an annual basis as a priority in its Strategic Plan.

1. Summary of citizen participation process/Efforts made to broaden citizen participation Summarize citizen participation process and how it impacted goal-setting

Annually the City conducts a minimum of two public hearings to allow the public an opportunity to comment on the Consolidated Plan and/or Annual Action Plan as well as the Consolidated Annual Performance Evaluation and Report. All public hearing meetings are advertised in a local newspaper of general circulation (in English and Spanish), and on the City's website. An initial public hearing to gather public input on housing and community development needs, goals and priorities, and funding allocations for the 2018-2019 program year occurred on April 3, 2018.

A 30-day public comment period was then provided for the Draft 2018-2019 Action Plan to give the public the opportunity to review the City's stated priorities for its 2018-2019 CDBG program and submit comments. This public comment period was advertised in a local newspaper of genreal circulation (in both English and Spanish), and on the City's website. Potential stakeholders and interested parties were also emailed a notice of availability for the opening of the comment period on the Draft Action Plan as well.

In addition, the City solicited comments on the Action Plan by contacting other local, County, regional districts providing services in and around the City of Goleta, as well as directly soliciting comments from the area public housing authority and other local public service providers, including those serving the homeless, seniors, youth, special needs populations and those with HIV/AIDS.

A second public hearing is scheduled for June 5, 2018, whereby the final 2018-2019 Action Plan will be considered and approved by City Council, then submitted to HUD. The 30-day public review period has been extended to June 5, 2018 to allow the community an opportunity to review an updated version of the Draft Action Plan which contains the City's actual 2018-2019 CDBG allocation amounts. The prior publicized version had been based on funding estimates, as the City had not yet received its allocation from HUD.

The City expects to receive CDBG funds for use to address the community needs. In addition to its entitlement grant, the City of Goleta typically allocates some General Fund money towards public services and leverages other funding and grants for new or repaired infrastructure in Old Town, the area with the highest percentage of low- to moderate-income people. For example, the City will be allocating over \$54,980 in fiscal year 2018-2019 for services to assist homeless people through support to warming shelters; for Fair Housing Services to predominantly low- to moderate-income residents through a contract with the City of Santa Barbara for its Rental Housing Mediation Program; and for monitoring of

affordable housing covenants by the Housing Authority of Santa Barbara County.

## Explain how federal funds will leverage those additional resources (private, state and local funds), including a description of how matching requirements will be satisfied

All sources and types of matching funds are more limited now due to the current economic climate, along with the demise of California redevelopment tax-increment funds and housing set-aside funds, and draw-down of local housing trust funds. However, as in the past, jurisdictions will be as creative as possible to find other sources of funding from state, federal, private developer, state tax-credit, or local funding, such as the housing trust funds, in order to develop and deliver efficient and cost effective projects. Although the City's CDBG allocation is limited relative to the cost of new housing and public improvements, these CDBG funds can serve as matching funds for other grant opportunities or can provide much needed gap funding when local resources fall short.

If appropriate, describe publically owned land or property located within the jurisdiction that may be used to address the needs identified in the plan

All of the CDBG-supported capital projects included in the past and for the 2018-2019 program year involve improvements in Old Town Goleta on publicly owned land or within public rights-of-way. For 2018-2019, \$140,633.35 will be allocated to the construction of a midblock crosswalk on Kellogg Avenue, north of Hollister Avenue and south of Armitos Avenue, which will provide safe pedestrian access to a future planned park in Old Town.

#### Discussion

The City has been very successful in leveraging financial resources and in additional to CDBG funding, has successfully competed for many other grants from varying sources, including U.S. Department of Transportation sponsored Transportation Investment Generating Economic Recovery (TIGER) Grants.

The City of Goleta's CDBG funding for capital projects and public improvements is concentrated in Census Tract 30.01 which includes Goleta's Old Town district. This area contains the City's highest concentration of low- to moderate-income residents and is the only census tract that exceeds the HUD exception threshold for Goleta. HUD typically defines a low- and moderate-income area as an area (often a Census Tract) where at least 51 percent of the residents are low and moderate income. However, in some communities, there are no or very few areas in which 51 percent of the residents are low and moderate income. For these grantees, the CDBG regulations authorize an exception criterion in order for such grantees to be able to undertake area benefit activities. The City of Goleta is one of the communities where the exception criteria applies. Only one Census Tract in Goleta (30.01) has a low- to moderate-income concentration above the exception threshold. This Census Tract makes up Goleta's Old Town district, where 8% of the population is below poverty level and the median income of the area is below 80% of the median income for the larger population in Goleta.

CDBG funding for Public Services is directed at low- to moderate-income people citywide.

### Rationale for the priorities for allocating investments geographically

## **Affordable Housing**

### AP-55 Affordable Housing – 91.220(g)

#### Introduction

Lower-income households continue to pay high percentage of their income for housing, compared to other income groups. A large percentage of lower-income renters also experience overcrowding and inadequate housing conditions as housing problems. The data indicate that generally over 90% of the extremely low-income renters, including the elderly, experience a cost burden that is greater than 50 percent of their income. Overall, of the 1,500 renter households in need of assistance, about 1,185 of these or 79% are experiencing a cost burden that is greater than 50 percent of their income. Of the 1,175 owner households needing some kind of housing assistance, the greatest problem is in the area of housing cost burden with 715 households (nearly 61%) experiencing a cost burden greater than 50% of their income. Another 275 owner households (23%) are experiencing a cost burden greater than 30% of their income. Unfortunately, the cost of land coupled with high development costs and lack of funding resources make development of new affordable housing units very difficult. The City of Goleta has limited resources with which to develop new affordable units and often relies on private developers to do so in conjunction with other projects.

### **AP-60 Public Housing – 91.220(h)**

#### Introduction

The Housing Authority of the County of Santa Barbara serves Santa Barbara County and the City of Goleta. Within the City of Goleta, the Housing Authority has 140 units, including 4 units for special needs people. There are also 236 people receiving Section 8 housing assistance in the Goleta area. The Housing Authority was founded on the belief that decent, safe and sanitary housing is central to the physical and emotional health, productivity, and self-esteem of the people it serves. The agency's mission is to provide affordable housing opportunities for low income households in the County of Santa Barbara (including Goleta) in an environment which preserves personal dignity, and in a manner which maintains the public trust.

### Actions planned during the next year to address the needs to public housing

The City is not aware of any specific projects related to public housing in the coming year. However, in the past few years, the Housing Authority of the County of Santa Barbara has methodically worked toward rehabilitation of all of its public housing units in Goleta. The Housing Authority has accomplished this through the establishment of a non-profit affiliate; disposition of the units to this non-profit affiliate; and then use of tax-exempt financing/credits to finance rehabilitation of the units. The units remain affordable and Section 8 vouchers have been issued for any tenants displaced during renovation of the units.

As funding allows, the Housing Authority of Santa Barbara County will carry out modifications needed in its public housing stock based on the Section 504 Needs Assessment. A review of the Housing Authority's 2017 Agency Action Plan does not indicate any new or rehabilitation projects in the City of Goleta for 2018-2019. Please refer to the Public Housing Authority's Annual Plan for further information.

# Actions to encourage public housing residents to become more involved in management and participate in homeownership

Each public housing area owned and/or managed by the Housing Authority of the County of Santa Barbara has an established Resident Council, whose members are elected by residents in that area. The Council holds regular public meetings and brings concerns and recommendations directly to the Housing Authority. The Housing Authority also has a Section 8 homeownership program, although the high cost of housing limits it. The Housing Authority also administers a Mortgage Credit Certificate Program that assists lower income first-time homebuyers.

# AP-65 Homeless and Other Special Needs Activities – 91.220(i) Introduction

The City of Goleta strives to reduce homelessness and assist those who are homeless and unsheltered by using a portion of its CDBG award to support agencies and organizations whose mission is to provide case management and other services to homeless persons. The City has typically supported programs and activities that also specifically engage in outreach to the homeless not residing in shelters. In addition to allocating some of its CDBG funding, the City has typically invested some of its General Funds in homeless warming centers and in support of the Central Coast Collaborative on Homelessness (C3H). C3H recently transitioned to "Home for Good Santa Barbara County." Home for Good is a county-wide, collective impact collaborative of government agencies, non-profit organizations, foundations, faith communities, business and community leaders, other community groups, and individuals who have experienced homelessness. Its goal is to prevent homelessness; support the expansion of housing for people experiencing homelessness; build a results- and data-driven culture; elevate community dialogue, support and collaboration regarding homelessness; and encourage commitment to self sufficiency.

# Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

## Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The City of Goleta strives to reduce homelessness and assist those who are homeless and unsheltered by using a portion of its CDBG award to support agencies and organizations whose mission is to provide case management and other services to homeless persons. The City has typically supported programs and activities that also specifically engage in outreach to the homeless not residing in shelters. Through its support of New Beginnings Safe Parking and Homeless Outreach Program, the City expects to assist 50 homeless people not residing in shelters.

#### Addressing the emergency shelter and transitional housing needs of homeless persons

There are several organizations and agencies that serve southern Santa Barbara County and provide both emergency shelter as well as transitional housing. There are also warming centers, some located around Goleta, that serve area homeless people during periods of inclement weather by providing shelter and meals. The City typically contributes City General Fund money on an annual basis to the warming centers emergency shelter program, and also devotes a portion of its CDBG allocation to

organizations that provide services to homeless persons and families.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The City of Goleta's goals include reducing the incidence of homelessness, and addressing the needs of homeless persons, including making the transition to permanent housing and independent living. The City helps achieve this through support of agencies that provide these services, as well as through participation in area organizations that share these goals. As mentioned above, one of those organizations is Home for Good, which includes a Goleta City Councilmember on its advisory board. The City typically provides some General Fund support to Home for Good for its regional, collaborative effort focused on housing those without homes that brings together homeless services agencies, government, community based organizations, other local groups, non-profits, foundations, faith communities, street friends, business and community leaders, and individuals. The goals of Home for Good include preventing homelessness and supporting the expansion of housing for the homeless.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

The City of Goleta looks to help avoid low-income people from becoming homeless by providing rental and eviction prevention assistance through the City's annual contract with the Santa Barbara Rental Housing Mediation Program (RHMP). The City provides nearly \$30,000 in General Fund money to support the RHMP which provides information to predominantly low-income tenants about their rights; provides legal assistance to people served with eviction notices; and conducts mediation between tenants and landlords to help people avoid eviction and address other problems. The City also allocates a portion of its CDBG funding to homeless service providers and non-profits that provide various services and assistance to low-income people including utility assistance, weekly food baskets, and medical assistance. These services fill the gaps for those families and individuals that are on the verge of

becoming homeless and allow them to dedicate more of their financial resources to housing costs.

### AP-75 Barriers to affordable housing – 91.220(j)

#### Introduction:

In the City of Goleta, the largest barrier to the development of affordable housing is the extremely high cost of real estate and development costs. There are also considerable governmental constraints to affordable housing development that include land use policies governed by the Land Use Element of the General Plan and the zoning and development codes, and development fees imposed by the jurisdiction. In addition, due to the prolonged drought, there is a restriction on issuance of new water service which represents another barrier.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The City's Housing Element is required to provide a detailed assessment of public policy constraints and to develop strategies to alleviate the constraints on development of new housing, and particularly, those that act as barriers to affordable housing. Major governmental constraints to affordable housing development include land use policies governed by the Land Use Element of the General Plan and the zoning and development codes, and development fees imposed by the jurisdiction. For example, stringent standards relating to building height, lot coverage, setbacks, open space requirements, and parking requirements often reduce the number of units that can be achieved on a given site. In addition, lengthy development approval and permit processing procedures can increase the cost of development substantially. In most cases, lengthy development and permit approval process occurs when a conditional use permit and/or design/architectural review are required and if clear standards for review are not established. Development impact fees are also charged to a new development to pay for the necessary local infrastructure to serve the development which increases the cost to develop new housing. The City of Goleta has been in the process of developing a new zoning code that is expected to be adopted in 2018-2019, and in doing so, has carefully examined current development standards, land use policies, and permit processing requirements to remove unnecessary barriers to development of affordable housing. This included an examination of current land use controls to determine where processing efficiencies can be improved.

### **Discussion:**

Using support from sources like HOME funding and the City's affordable housing in-lieu fees, construction will be completed on dozens of affordable housing units in the 2018-2019 program year. This is expected to be the most number of affordable housing units completed since the City's incorporation in 2002, and are evidence that the City is having some success in breaking down the

Annual Action Plan 2018 barriers to affordable housing.

### **AP-85 Other Actions – 91.220(k)**

#### Introduction:

The greatest obstacle to meeting any underserved need is the lack of sufficient funding, including:

- Limited availability of funding from both federal, state and other sources;
- High cost of housing and provisions in the area which increases the difficulty of meeting affordable housing needs; and
- Reduced or frozen funding from state, including the loss of Redevelopment Funds and other sources due to inadequate state revenue

There is an underserved need for public services across most categories. This includes the needs of the elderly and frail seniors, at-risk youth, working parents, persons with HIV/AIDS and their families, the disabled, individuals with drug, alcohol and chronic illnesses, and persons with other conditions affecting their ability to function independently and productively. There is also a need for general services for low-income residents such as health care, food and clothing, educational programs, and case management.

### Actions planned to address obstacles to meeting underserved needs

The City of Goleta will provide the maximum amount of CDBG funding allowed towards public services (15% of its allocation) which will help address the needs of seniors, youth, homeless and low-income people in general, including essential needs such as health care and needed family resources for low-income parents.

There is a need within the City, particularly the City's Old Town district, for public facilities to serve populations in this area or to rehabilitate aging facilities. The Old Town area has the City's highest concentration of low- and moderate-income residents. Old Town is characterized by older neighborhoods that either do not have proper facilities or their existing facilities suffer from heavy use and deferred maintenance leading to disrepair. Needed public facilities include parks and recreational amenities, flood control improvements, and sidewalk and street improvements. To address these unmet needs, the City will allocate approximately 65% of its CDBG funding for infrastructure and capital improvements in the Old Town area. This CDBG funding will also provide for leveraging opportunities to provide the greatest impact to the largest number of residents.

In an effort to address these underserved needs, City staff will also address the challenges of existing and new obstacles in 2018-2019 by focusing on the following programmatic and administrative areas:

 Staff will continue to research availability of future funding resources and use proactive approaches toward future applications for potential leverage funds; this will assist the City to

- strategically place future activities in line to address the above obstacles.
- CDBG and other funds will be used as leverage for the City administered programs and support services that serve the needs of low- to moderate-income citizens.

### Actions planned to foster and maintain affordable housing

The high cost of housing in the area significantly increases the difficulty of meeting affordable housing needs and the City has limited resources with which to develop affordable units on its own. Staff will continue to research and explore public/private partnerships in the construction and development of affordable housing. The City will continue to look for opportunities to leverage its HOME funds and affordable housing in-lieu fees to assist private developers in the construction of new affordable housing. A few such partnerships have led to the successful approval and financial support of projects that will complete construction of 91 affordable units in 2018-2019 including:

- Village at Los Carneros 69 affordable rental units (13 targeted to very low-income and 56 low-income)
- Old Town Village 14 affordable ownership units (7 at moderate-income and 7 at above moderate-income)
- Vila la Esperanza 8 new rental units (all units will be low-income units)

### Actions planned to reduce lead-based paint hazards

The Santa Barbara County Public Health Department works in coordination with the California Department of Health Services, Childhood Lead Poisoning Branch for program planning, outreach, case management, investigation, and surveillance of lead poisoned children.

A Public Health Nurse (PHN) identifies and case-manages lead-burdened children throughout the county and provides outreach and education to the community. A multi-departmental Childhood Lead Poisoning Prevention (CLPP) Team, which includes representatives from the Women, Infants, and Children (WIC) program, California Children Services (CCS), Environmental Health Services, Community Health Division Program Administration, and the County Fire Department-HAZMAT, meets quarterly to plan outreach activities, prepare educational materials, resolve current issues, and discuss responsibilities in investigating lead poisoning cases. This program has increased lead screening done on children at risk for lead poisoning.

The City of Goleta will also make copies of the most recent EPA publication, Renovate Right: Important Lead Hazard Information for Families, Child Care Providers and Schools available to the public at City Hall. In addition, the City's Planning and Environmental Review Department will provide the most recent EPA educational brochures on lead poisoning to anyone seeking a permit or information for renovation

of a residence, day care center or school which includes work on a structure older than 1978.

### Actions planned to reduce the number of poverty-level families

The City of Goleta will support various public service programs, both with its CDBG funding and with its own General Funds, to provide essential services aimed at helping to reduce the number of poverty-level families.

### Actions planned to develop institutional structure

One of the institutional gaps identified was that few services are located in the City of Goleta so residents have to travel to receive services. The City will continue to work with service providers to offer services in Goleta, and will support those programs that do, with CDBG and/or City General Fund money. For example, two years ago the City assisted the Santa Barbara Neighborhood Clinics in the opening of two new clinics in Goleta to provide free or low-cost medical and dental care to Goleta residents. Prior to this, the nearest clinics were outside the City, in Isla Vista or Santa Barbara, so a significant number of Goleta residents had to travel a significant district to reach these services.

# Actions planned to enhance coordination between public and private housing and social service agencies

The City will continue to collaborate with public and private housing and social service agencies to meet the goals and objectives of the Consolidated Plan. This may include ongoing meetings, special meetings and/or participation on relevant tasks forces.

Hi Lisa,

Thank you so much for your comments. It is always nice to hear back from the community on these topics. I wanted to share a few details about the CDBG program that you may not be aware of. Unfortunately, the federal government (HUD) limits what we can spend on programs and services to 15% of the total grant allocation that we receive. So for example, in the next program year we are estimating receiving about \$173,000 in total CDBG funding. Of that amount, only 15% can go towards programs and services such as the types you mention that would assist the homeless population (approximately \$26,000). The other two subcategories of expenditures for this grant are capital improvement projects (65%) and planning and administration of the grant (20%). That is why you see such a large portion of that funding going towards capital/ construction projects.

Of course, it would be ideal if this grant were a bit more flexible in how the funds can be spent. In addition to CDBG, the city does utilize other funding to address homelessness. I've included a few others on this email in case they would like to

chime in. Our Economic Development Coordinator, Jaime Valdez, may be better able than I to speak to your thoughts about housing the homeless population by partnering with nonprofits.

Thank you again. Please let me know if you have other comments or questions about this grant.

Thank you so much for sending this information.

I don't know how to say this without being blunt, because I am so disappointed and upset.

In the past several years we spent over \$300,000 of grant money on bike lanes/paths. While this is noble and does help certain citizenry, it seems to pale in comparison to homelessness.
Another \$100000 plus for sidewalk improvements. This should be covered by the city coffers, shouldn't it?
Except for the monies being donated to the clinics and other resources for homeless and low income people and families, we need to commit the balance of the money to housing the homeless from our community.
We have people of our community living in dirt. We could have housed dozens of them in the past years! There are apartments right now in Goleta for less than \$1500 per month that could be rented to place the homeless!
The waiting list for most individuals is 1 to 5 years in "other" housing.
I imagine a partnership would need to be struck with a non-profit organization to send the funds to. But the City and the non-profit would design a housing program that works for the City of Goleta and it's homeless. Specific individual requirements. Accountability. Temporary.
This would be the humane action with these funds, and it should be part of a larger plan to end homelessness in Goleta, and the resulting blight. It is possible. We just have to stop with bandaid decisions and be BOLD.

### **General Instructions**

When additional sheets are prepared for Section A, provide similar column headings on each sheet. For each program, function or activity, fill in the total requirements for funds (both Federal and non-Federal) by object class categories.

Line 6a-i - Show the totals of Lines 6a to 6h in each column.

Line 6j - Show the amount of indirect cost.

Line 6k - Enter the total of amounts on Lines 6i and 6j. For all applications for new grants and continuation grants the total amount in column (5), Line 6k, should be the same as the total amount shown in Section A, Column (g), Line 5. For supplemental grants and changes to grants, the total amount of the increase or decrease as shown in Columns (1)-(4), Line 6k should be the same as the sum of the amounts in Section A, Columns (e) and (f) on Line 5.

**Line 7** - Enter the estimated amount of income, if any, expected to be generated from this project. Do not add or subtract this amount from the total project amount, Show under the program

narrative statement the nature and source of income. The estimated amount of program income may be considered by the Federal grantor agency in determining the total amount of the grant.

### Section C. Non-Federal Resources

**Lines 8-11** Enter amounts of non-Federal resources that will be used on the grant. If in-kind contributions are included, provide a brief explanation on a separate sheet.

**Column (a)** - Enter the program titles identical to Column (a), Section A. A breakdown by function or activity is not necessary.

**Column (b)** - Enter the contribution to be made by the applicant.

**Column (c)** - Enter the amount of the State's cash and in-kind contribution if the applicant is not a State or State agency. Applicants which are a State or State agencies should leave this column blank.

**Column (d)** - Enter the amount of cash and in-kind contributions to be made from all other sources.

Column (e) - Enter totals of Columns (b), (c), and (d).

Line 12 - Enter the total for each of Columns (b)-(e). The amount in Column (e) should be equal to the amount on Line 5, Column (f), Section A.

# Section D. Forecasted Cash Needs

**Line 13** - Enter the amount of cash needed by quarter from the grantor agency during the first year.

**Line 14** - Enter the amount of cash from all other sources needed by quarter during the first year.

Line 15 - Enter the totals of amounts on Lines 13 and 14.

# Section E. Budget Estimates of Federal Funds Needed for Balance of the Project

Lines 16-19 - Enter in Column (a) the same grant program titles shown in Column (a), Section A. A breakdown by function or activity is not necessary. For new applications and continuation grant applications, enter in the proper columns amounts of Federal funds which will be needed to complete the program or project over the succeeding funding periods (usually in years). This section need not be completed for revisions (amendments, changes, or supplements) to funds for the current year of existing grants.

**Line 20** - Enter the total for each of the Columns (b)-(e). When additional schedules are prepared for this Section, annotate accordingly and show the overall totals on this line.
