SUBJECT: Santa Barbara County Library Advisory Committee Appointee

RECOMMENDATION:

Consider the reappointment of Patricia Kistler to the Santa Barbara County Library Advisory Committee by the Santa Barbara County Board of Supervisors.

BACKGROUND:

The Board of Supervisors created a county-wide Library Advisory Committee so that representatives of communities with libraries operating as part of the regional free library system could meet quarterly to discuss issues of mutual concern. The Board determined that each contracting city may nominate one citizen from that community to serve as a member to the Committee. The term limits are one-year, beginning on July 1 and ending June 30 of the following year.

The Library Advisory Committee meets quarterly to review services and operations, and to make advisory recommendations to the Board of Supervisors and cities participating in the County library system. The next meeting is scheduled for September 19, 2018.

DISCUSSION:

The purpose of this agenda item is to allow the City Council the opportunity to reappoint Patricia Kistler to the Santa Barbara County Library Advisory Committee with a term ending June 30, 2019. The City of Goleta appointee will then be considered and confirmed by the Santa Barbara County Board of Supervisors.

The City Clerk's Office published the advertisement for the Santa Barbara County Library Advisory Committee vacancy in the local adjudicated paper.

Meeting Date: June 19, 2018

Staff reached out to Council's current appointee Patricia Kistler and she requested that staff resubmit her application for this position and noted her commitment to the committee and the work underway (Attachment 1). No other applications were received.

ALTERNATIVES:

Council is under no obligation to make an appointment at this time. Taking no action would mean that Mrs. Kistler and staff would continue to attend meetings until a new appointment is made. Council may desire to see further advertising done in order to ensure a greater applicant pool, prior to a selection process.

FISCAL IMPACTS:

The only fiscal impact associated with this agenda item is staff time. No expenditure of City funds is involved with nominating an appointee to the Santa Barbara County Library Advisory Committee.
