RECOMMENDATION:

- A. Conduct candidate interviews for the Parks and Recreation Commission; and,
- B. Appoint one candidate to fill the remainder of the term of a vacant seat on the Parks and Recreation Commission, and one candidate to fill the vacant Student Commissioner term on the Commission.

BACKGROUND:

There are two vacancies on the Parks and Recreation Commission: one for the unexpired portion of a term ending January 2019; and, one to fill the vacant student member of the Parks and Recreation Commission.

The Parks and Recreation Commission is a seven member body with responsibility to provide citizens a platform to discuss the needs, opportunities and current offerings of parks and recreation activities in the City. Each Parks and Recreation commissioner is appointed by the City Council on an at large basis.

DISCUSSION:

On April 4, 2018, Jose Tolis notified staff that because he was graduating, he would be resigning from the Parks and Recreation Commission. On April 17, 2018, the City Council affirmed Councilmember Bennett's appointment of Anne Linn to the Planning Commission, which created a vacancy on the Parks and Recreation Commission, as Ms. Linn had been serving as a Parks and Recreation commissioner. Accordingly, there is an opportunity for the Council to appoint two new commissioners, one to serve the unexpired portion of the term ending January 2019 left by Ms. Linn, and one to fill the vacant student position with a term of one year.

Requests for applications were published on Channel 19, the Monarch Press, The Independent and posted at various locations throughout the City, as well as, Dos Pueblos High School. The City received two applications for the student position from Nora Kelly and Julianna Ibarra (Attachments 1, and 2). Staff has confirmed interview times for these applicants. The City has received two applications from Claudia Dato and Richard Dennison for the regular position vacancy on the Commission (Attachments 3 and 4).

This agenda item allows the City Council the opportunity to conduct interviews and consider the appointment of the candidates. The table below lists the candidates and their interview scheduled times.


