E. DIRECTOR'S REPORT

Carmen Nichols, Deputy City Manager requested that Andrea Moreno, Administrative Assistant, provide an update on Arbor Week and Mr. Morgenstern will provide an update on La Patera Project and the Palm Trees at the Hilton.

Andrea Moreno, Administrative Assistant, noted Arbor Week is March 7- 14, 2018, and to commemorate the occasion a Proclamation was previously presented by the City Council. Ms. Moreno also reported that the Annual Tree Planting Ceremony will take place at Stow Grove Park on Monday, March 12, 2018, at 9:30 A.M. and the public is invited to attend.

Bob Morgenstern, Public Works Manager, responded to Commissioner's Lovelace question about the parks in Santa Barbara County. He reported that Santa Barbara County's Tree List for Goleta may be outdated. Mr. Morgenstern responded to Commissioner Kirby's question related to the Palm Trees located on the Hilton property. Mr. Morgenstern noted that the trees are private trees, the City of Goleta has no control over those trees. If the Commission feels they are a hazard, staff could contact the Hilton and request that they be trimmed. Mr. Morgenstern provided an update on the Rancho La Patera tree trimming near the Train Depot and reported that after a number of risk assessment on the trees had been completed, the City Council previously voted to have three of the dangerous trees trimmed back.

Carmen Nichols, Deputy City Manager, reported on February 20, 2018, staff provided an update to the City Council on the Ellwood situation. At that meeting, staff presented: 1). Butterfly population count and trends that are occurring; 2). the Coastal Commission Tree Removal Trail Closure Emergency Permit Implementation, 3). New Tree Surveys and Risk Assessment issues and recommendations, 4). the Habitat Management Plan and 2018 Tree Action Plan and 5). Quality Environment Review of the Habitat Management Plan. Updates were provided at that meeting and the item was continued with the exception of the budget appropriation items which were approved. The Public Tree Advisory Commission was encouraged to attend that meeting when the item is presented at a future City Council meeting.
