CALL TO ORDER AND PLEDGE OF ALLEGIANCE

PUBLIC FORUM

Richard Foster expressed confusion pertaining to an annual report which he was told would not available, however noted the Urban Forest Management Plan (UFMP) approved by the City Council said an annual report was ordered and is required. Mr Foster raised concerns on item B.3 which contains a proposed re-draft of the

UFMP with an action plan being introduced. Mr. Foster noted the UFMP is only to be reviewed every ten years and wondered why the City had the consulting arborist review the UFMP. Mr. Foster concluded by saying the Public Tree Advisory Commission addresses the entire urban forest, not just street trees.

Mr. Bruns commented that the Public Tree Advisory Commissions job is to manage trees on city owned property, not to manage trees on private property.
