General Business License History

- County Ordinance adopted upon incorporation in 2002
- Required a Business License (BL) for businesses without a fixed location in the City
- Annual amount of \$100

General Business License History

- May 2008 Study presented by Management Partners to evaluate alternatives of BL tax programs (6 alternatives identified)
- June 2008 Council directed a fee based alternative
- November 2008 Resolution approving an administrative fee of \$23 for new BL and \$15 for renewals (after CPI adjustments these fees are currently at \$25 and \$16)
- December 2009 Ordinance approved amending the BL Ordinance for a BL annual amount of \$100 or \$25 per quarter to businesses within the City

General Business License History

- January 2010 Implementation of new BL requirements
- Notifications to 2,414 businesses as identified per the Management Partners Study
- Compliance increasing since 2010 and consistent with Study projections of 2,414 business and estimated revenues of \$275K

- Business License Software Module implemented use in FY 07/08
- Fiscal Year 2017/18 budget includes a business license revenue estimate of \$263,000
- Full Cost Allocation Plan and Comprehensive User Fee Study to begin soon, and will evaluate all user fees currently charged by the City for full cost recovery, including business license fees. Depending on outcome of this study and future direction by Council, revenues may be adjusted in future years.

- -Taxicabs have an additional \$5 annual fee per taxicab sticker (not included in amount above)
- -Renewal fees may differ due to the specialty type license
- -Fees were adopted and set by ordinance
- -Tobacco passthrough costs of \$379 transmitted to County Public Health Department for processing and administration of program
- -Marijuana Delivery Driver/Service passthrough costs of \$56 to Sheriff's Office for background checks/live scan

- Fee increase by \$3 (through 2023)
- City annually collects approx.
 \$1,490 and now anticipating
 \$7,600 (\$6,110 increase or 410%)
- Forms and website updated
- No current programmed use yet
- \$7,800 current total balance since inception
- Quarterly remittance of fees to State
- Annual Reporting required

Purpose of fee is to increase disability access and compliance with construction related accessibility requirements. Additionally the fee assists local jurisdictions in supporting the Certified Access Specialists (CASp) program, and provides the Division of the State Architect (DSA) with funds to maintain oversight of the CASp program
