Cannabis Business License Ordinance

- Introduce and conduct the first reading (by title only), and waive further reading of Ordinance No. 18-__ entitled:

“An Ordinance of the City Council of the City of Goleta, California, Repealing and Replacing Chapter 5.09 of Title 5 of the Goleta Municipal Code to Establish Standards and Regulations for Commercial Cannabis Uses”

Cannabis Business License Ordinance

- Proposition 64 passed in November 2018 legalizing Marijuana.
- Allowing local governments to regulate commercial cannabis operations or completely prohibit it.
- June 2017 Medicinal and Adult-Use Cannabis Regulation and Safety Act (MAUCRSA).
- Affirmative action by Council in 2016 and 2017 to allow Cannabis Business, under local control.
- Workshop on June 6 and Committee Review June 11

Cannabis Business License Ordinance

- Cannabis Land Use Ordinance
 - Allows and regulates recreational (adult-use) cannabis
 - Develop the framework to regulate medicinal and recreation cannabis uses.
- Cannabis Land Use Ordinance Addresses:
 - What-type of operations are allowed
 - Where-the operations are allowed
 - How – the cannabis uses will be permitted

Cannabis Business License Ordinance

- CBL Ordinance:

- Establishes the regulation and licensing of medicinal and adult-use cannabis businesses.
- Conformance with state and local laws

- Regulations:

- Controlling and Regulating cannabis operations with specific business operating requirements
- Designed to minimize negative impacts
- Promote health, safety and general welfare of the community

Cannabis Business License Ordinance

- CBL repeals Section 5.09 (“Marijuana Delivery Regulations”) of the Goleta MC and replaces it with the amended section 5.09
- Land Use Reference
 - Type of License is determined by Land Use Ordinance
- Cannabis Business License
 - All commercial operators (adult use/medicinal use) including primary care givers are required to obtain a business license
 - A regular City business license is not required
