- **SUBJECT:** Naming of the New Park in Old Town

RECOMMENDATION:

Approve the Standing Naming Committee's recommendation of "Jonny D. Wallis Neighborhood Park" as the permanent name for the new park in Old Town.

BACKGROUND:

On September 4, 2018, the City Council approved a naming contest encouraging the public to assist in naming the largest park built in the City's history. The contest opened on Wednesday, September 5, 2018 and closed on Thursday, September 20, 2018 with 341 entries. At that same meeting, the City Council approved a process that would allow the Parks & Recreation Commission (P & R Commission) the opportunity to review a short list (Attachment 1) provided by the Standing Naming Committee (Naming Committee) for the Naming Committee's final recommendation to the City Council. The Naming Committee initially reviewed all 341 contest entries and confirmed compliance with the naming policy before providing the short list.

At their regular meeting on October 3, 2018 the P & R Commission reviewed the list provided by the Naming Committee, received public comment, deliberated and provided a recommendation to the Naming Committee for its consideration as a final recommendation to the City Council.

DISCUSSION:

On September 24, 2018 the Naming Committee met to review the entries submitted for the Naming Contest and provided a list of six possible names to the P& R Commission for consideration for Hollister/Kellogg Park, listed below in alphabetical order.

- Esperanza Park
- Goodland Park
- HéLó Village Park
- Jonny D. Wallis Neighborhood Park

- Kids Dream Park
- Qasil

On Wednesday, October 3, 2018, the P & R Commission reviewed the list of names, received public input and provided a recommendation for consideration. The P & R Commissioners initially discussed four out of the six names. There were three votes for Esperanza Park, two votes for Goodland Park, one vote for Jonny D. Wallis Neighborhood Park and one vote for Kids Dream Park. All the P & R Commission members unanimously agreed that while there was not enough support to name the park Jonny D. Wallis Neighborhood Park, there was a strong desire to have some type of recognition for the efforts and contributions that Jonny Wallis made to the community, specifically in and for Old Town. Suggested recognitions were the planting of a tree or the dedication of an amenity in the park. The motion that passed with a unanimous vote was to recommend "Esperanza Park" to the Naming Committee, as the name for the park; and to support a form of recognition to Jonny Wallis at the Park. Commission members expressed a strong desire to connect the name of the park to the Spanish families in Old Town. "Esperanza" means "Hope" in Spanish, thus the intention for Esperanza Park as the recommendation from the P & R Commission. Residents of Old Town have been the primary participants in the design of this park and have been waiting over six years for a place to gather and play.

On Monday, October 8, 2018 the Naming Committee met to provide a final recommendation to City Council. The Naming Committee discussed the P & R Commission's recommendation but had concerns that the recommended name, Esperanza, was not a name that was specific enough to Old Town and this park. The Naming Committee received public comment in writing and in person (Attachment 2) with overwhelming support of, Jonny D. Wallis Neighborhood Park, which was one of the six names on the short list that had been provided to the Commission. The Naming Committee discussed each of the six finalists, explored the idea of combining more than one name and expressed a strong desire to include the elements of the Spanish and Chumash cultures in some way in the park, if not in the name. Staff informed the Naming Committee that the plans for the park do include interpretive signs, which could contain information about both the Spanish and Chumash cultures.

The final recommendation of the Naming Committee for the new park in Old Town is, Jonny D. Wallis Neighborhood Park. The Naming Committee understood the substantial contributions that Jonny Wallis made to the City of Goleta and its residents, especially in Old Town, and agreed that she was part of Goleta's history, identity and legacy and was deserving of this type of recognition.

ALTERNATIVES:

The Council may choose not to accept the recommendation from the Standing Naming Committee and instead consider the recommendation from the P & R Commission to approve "Esperanza Park", or consider one of the other finalists, or may request consideration of another entry from the contest or provide staff alternate direction.





I am Fermina Murray, a local historian who has done histories and walking tours of Old Town Goleta. I sent in, through the Surveys Monkey, that the new Old Town Goleta Park at Kellogg and Hollister Avenue should be named after the late Jonny Wallis.

Here are some of the main reasons why this Park should be named: Jonny D. Wallis - Neighborhood Park:

BACKGROUND ON JONNY WALLIS' ADVOCACY FOR PARKS AND RECREATION

Throughout her service on the Goleta Old Town Redevelopment Project Area Committee (PAC), the County of Santa Barbara Park Commission, the Goleta City Council, and the Goleta Planning Commission, Jonny championed the need for and value of parks, open space, and both active and passive recreation.

Many examples of her advocacy could be cited, but four efforts stand out:

While serving on the County of Santa Barbara Park Commission from 1999 to 2001, Jonny used her nsiderable powers of persuasion to convince the commission to reconsider its previous support of a proposal for active recreation on the Ellwood Bluffs. Among other features, the earlier proposal called for a BMX track, stables, food courts, nighttime lighting, and paid parking.

After revisiting the issue, the commissioners recognized the valuable opportunities for passive recreation available on this site. Their re-vote on the issue eased the way for the eventual land swap that led to the creation of the Ellwood Mesa preserve that we cherish and enjoy today.

Jonny's steadfastness during revenue neutrality negotiations with the County of Santa Barbara once more demonstrated her belief in the importance of parks and open space for the city-to-be. One prong of the negotiations dealt with the transfer of real property from the County to the new City of Goleta. Throughout the negotiations, County representatives insisted that Stow House and Lake Los Carneros constituted a regional park that should remain County property.

Jonny would hear none of the County's argument. She and her fellow negotiators hung tough, insisting that the park was part of Goleta's history, identity, and legacy, and that the property should be transferred to the city upon incorporation. Only on the last day of negotiations did the county yield. As a token of Jonny's leading the charge to acquire Stow House and Lake Los Carneros for Goleta, at the first city council meeting on February 1, 2002, a representative from County administration presented her with a key to Stow House.

Jonny Wallis lived in Old Town Goleta. Naming the park after her would be a unique tribute to OTG od the City.

negotiations did the county yield. As a token of Jonny's leading the charge to acquire Stow House and Lake Los Carneros for Goleta. at the first city council meeting on February 1. 2002, a representative from County administration presented her with a key to Stow House.

Nowhere, however, did Jonny advocate more steadily for increased park and open space than in Old Town, her home for 45 years. During the course of her community service, she long decried the dearth of recreational opportunities in Old Town. "We have one park, a play lot really," she would say. Then she would add, "It's on Nectarine and it's only 0.014 acres—that's "point-zero-one-four," she would explain, "not point-one-four and certainly not fourteen" for an area on the South Coast second in density only to Isla Vista.

Thus, when the opportunity to acquire the property for Armitos Park arose, Jonny was immediately on board. Not only did she support acquisition of the property with three council motions on July 5, 2005, but she approached a local nonprofit to discuss securing funding for the purchase over and above available city funds.

When she was leaving office in 2008, the city manager asked Jonny if there was any single project that she would like to see finished before her last day. She responded with completion of the Armitos Park. Well, the city didn't quite fulfill her wish. But she was thrilled to see the grading completed and the sidewalk laid before she left office.

Although Jonny had left the Goleta City Council before the acquisition of the Kellogg park site, she played her part in laying some of the groundwork. While serving on the Old Town PAC, she supported the callout in the Revitalization Plan for a possible two-acre park on the site. She was part of the council majority that created the park/recreation overlay for the Kellogg park site in the city's first General Plan in 2006. When the chance for the city to purchase the Kellogg park site came up in 2011, Jonny spoke to council urging a vote to acquire the property.

"More is involved in this decision than facts and figures," she said. "Others have dreamed of a large park for years. When the revitalization of OT was discussed in the 1990s they made it clear that parks were a top priority.... Fifteen or more years have passed and new generations of children must still play in the streets.... This is a legacy vote: you have it in your power to bring great benefit to our Old Town community, to significantly better the lives of people, and to make life happier and safer for lots of kids. Please don't falter.'

No one would be happier to see this dream coming true at last.

I ask that you add a second choice for the City Council's consideration. I think this would be appropriate because the Park and Recreation Commission member received the six names you recommended in the three page staff report. They should have received all the nominating forms for the six candidate names. The staff report had placed a packet of some of the nominating forms in front of each commissioner on the night of the meeting but with no time to read it.

It sounded from their comments that they had decided their personal choices and were surprised to hear the comments from the public. The public strongly supports the name Jonny Wallis Neighborhood Park and they had no way to know this. Some of the members didn't even know who Jonny Wallis was. The staff report should have provided more information than the few words after each name.

The name Esperanza reminds some of us of the low cost apartments and the homeless shelter that was downtown in Santa Barbara. These are not associations one would want to have regarding a park.

It takes a special kind of person to found a city – someone calm, reasonable, able to respect and mediate differences, with a clear sense of purpose and, above all, the ability to lead and move forward the vision of a new city. Goleta was fortunate to have such a leader in Jonny Wallis. There were many talented individuals in GoletaNow!, but Jonny was the touchstone that kept us on track and moving forward.

Prior to cityhood, she was deeply involved in Goleta, particularly in Old Town, where she lived, an area that she taught many of us to know and appreciate. She chaired the Old Town Project Area Committee, one of the first attempts to comprehensively address its future development.

She taught us that Old Town is, first and foremost, a neighborhood, not that different from the other neighborhoods that make up Goleta. Behind the Hollister streetscape of small, local businesses is a residential neighborhood of diverse people with relatively affordable housing and easily accessible, needed public transportation. Jonny resisted ideas of gentrification and focused instead on how planning for the area could avoid displacing current residents and local businesses, while improving their chances for success. She kept the focus on current Old Towners' desires for a clean, safe, livable area for workers and their families, with businesses that serve the needs of the residents. She was clear that if you wouldn't want it in your neighborhood, you should be careful not to wish it on Old Towners' **87**

She was involved in Goleta matters for many years before cityhood, active in the Citizens Planning Association Land Use Committee, Common Ground 2000, the Goleta Roundtable, and debates around issues of UCSB growth and Santa Barbara Airport impacts – anything that touched Goleta.

At the start of 1999, there were many community discussions regarding Goleta's future. From this emerged the activist group GoletaNowl, of which Jonny and the authors of this article were a part, focusing on the practical steps necessary to form a city. We met weekly for two years to develop a proposal for Goleta cityhood and shepherd it through all its stages: gathering signatures, negotiating with the county, raising funds, running the gauntlet of LAFCO hearings, and finally running a campaign. We were an ambitious group of nine with different backgrounds, different reasons to participate, and different styles and temperaments. Each member had important insights and skills to contribute, but looking back, there is little question that Jonny was the one who held that diversity together. Jonny Wallis: 1946 - 2013

It takes a special kind of person to found a city — someone calm, reasonable, able to respect and mediate differences, with a clear sense of purpose and, above all, the ability to lead and move forward the vision of a new city. Goleta was fortunate to have such a leader in Jonny Wallis. There were many talented individuals in GoletaNow!, but Jonny was the touchstone that kept us on track and moving forward.

Prior to cityhood, she was deeply involved in Goleta, particularly in Old Town, where she lived, an area that she taught many of us to know and appreciate. She chaired the Old Town Project Area Committee, one of the first attempts to comprehensively address its future development.

She taught us that Old Town is, first and foremost, a neighborhood, not that different from the other neighborhoods that make up Goleta. Behind the Hollister streetscape of small, local businesses is a residential neighborhood of diverse people with relatively affordable housing and easily accessible, needed public transportation. Jonny resisted ideas of gentrification and focused instead on how planning for the area could avoid displacing current residents and local businesses, while improving their chances for success. She kept the focus on current Old Towners' desires for a clean, safe, livable area for workers and their families, with businesses that serve the needs of the residents. She was clear that if you wouldn't want it in your neighborhood, you should be careful not to wish it on Old Town.

She was involved in Goleta matters for many years before cityhood, active in the Citizens Planning Association Land Use Committee, Common Ground 2000, the Goleta Roundtable, and debates around issues of UCSB growth and Santa Barbara Airport impacts — anything that touched Goleta.

At the start of 1999, there were many community discussions regarding Goleta's future. From this emerged the activist group GoletaNow!, of which Jonny and the authors of this article were a part, focusing on the practical steps necessary to form a city. We met weekly for two years to develop a proposal for Goleta cityhood and shepherd it through all its stages: gathering signatures, negotiating with the county, raising funds, running the gauntlet of LAFCO hearings, and finally running a campaign. We were an ambitious group of nine with different backgrounds, different reasons to participate, and different styles and temperaments. Each member had important insights and skills to contribute, but looking back, there is little question that Jonny was the one who held that diversity together. She had an uncanny knack for keeping us all moving in the same direction toward our common goals instead of our individual differences. Her methodical and thoughtful analysis kept us focused on solving problems and overcoming barriers, and her calm, good-natured, and usually unflappable presence soothed and calmed the group.

She had a quiet authority that enabled her to highlight what was important. She was trained as a lawyer and guided GoletaNow! through the legal complexities of incorporation. She and her team negotiated a revenue-neutrality agreement with the county, a difficult task requiring give-and-take on both sides. I am Kitty Bednar, a 30-year resident of Old Town Goleta.

I support naming the new park on Kellogg Avenue in honor of Jonny D. Wallis.

When I first met Jonny in 1964 during our freshman year in college, the word most often used to describe her was *quiet*. Only her closest friends and family ever saw the playful sense of humor and keen intelligence behind her calm demeanor. Community advocate was the last role anyone who knew her then would have expected her to fill.

Life brings many surprises, however, including a new role for Jonny. In 1996 the County of Santa Barbara released a draft revitalization plan for Old Town. One proposal called for buying up and demolishing eight houses to make way for a 50-unit apartment building on our block. One of those houses was Jonny's. She was as dismayed as any of her neighbors by the proposal. But what to do?

She could easily have accepted purchase money for her house and moved elsewhere. She chose instead to stand with her Old Town neighbors and fight. Jonny had found her voice. After that, she never looked back.

As chair of the Goleta Old Town Project Area Committee, a County of Santa Barbara park commissioner, a founder of the city of Goleta, a member of Goleta's first city council, a member of SBCAG--whatever committee, board, or commission she served on--Jonny championed Goleta and especially Old Town.

Jonny believed that the creation of more parks and open space in Old Town was essential to the revitalization effort. She gave that goal equal weight with resolving flooding and circulation issues.

As a councilperson she was instrumental in the creation of Armitos Park and helped lay the groundwork for the creation of the new park on Kellogg. Naming that park in her honor would be a fitting tribute to one of Goleta's finest. She valued parks, she cared for Goleta, she believed in her Old Town neighbors, and she played a crucial role in the history of our young city.
