
Dear Chair Branch and DRB members,

To Scott Branch, Chair and members of the Goleta Design Review Board:

We have reviewed the plans for the hotel project at 5955 Calle Real (Case No. 16-097-DRB) and have concerns about it.

This project is too large for its location. Its size, bulk and scale are out of proportion with the existing surroundings.

Although the plans show it is just under the height limit of 35', it is too tall. There are no other buildings close by that are this high with the exception of the fitness center which is about 4' lower and has a much smaller profile. The tallest are 2 story buildings and this project with a proposed height of 34' would extend well beyond the roofline of most of the adjacent buildings. This height, also, would partially obstruct views of the mountains from 101 and the northbound offramp at Fairview.

Additionally, with its size, bulk and scale, this project will bring a significant change to the current character of the area. This would be the fourth hotel along this 2 block section of Calle Real. The Best Western Hotel, the Goodland Hotel and Motel Six are all two story buildings that impose less on their surroundings. This project, rather than fitting in to the existing streetscape, will be an outlier.

The project has too much hardscape and needs more and better landscaping. There is already too much hardscape with the parking areas for Zodos, Motel Six and the strip mall. A comparable and much better integrated hotel, with landscaping that softens its view from the street, is the Best Western Hotel at Calle Real and N. Kellogg.

It is very important that story poles be erected to give neighbors and residents a better understanding of the size, bulk and scale of this project and how it would relate to the surroundings before it proceeds through the review process.



I had planned to attend the DRB meeting tomorrow but have had a family emergency come up. For this reason I am writing you on behalf of NTGS (New Town Goleta Safety) at this last minute.

I have attended previous meetings focused on this project and voiced my concerns about the need for a crosswalk from the hotel property across Calle Real. In the last meeting I attended, the developers and DRB all seemed to agree that this was a good idea and the developer said that they would look into it. In reviewing the current plans I do not see any indication of a proposed crosswalk.

This stretch of Calle Real from Fairview to Encina Lane is almost 3 city blocks long (over 500 feet). We know that people staying at the hotel will be crossing the street to get to the businesses on the other side (the bank, charging station, Rusty's Pizza, Walgreens, and others). A controlled, on demand, crosswalk would support safety for pedestrians in this area. This is the responsible and forward thinking thing to do.

Please include in your proposal a controlled, on demand, crosswalk on the eastern end of your hotel property proposal.





Dear Chair Scott Branch and Members of the Board:

We are writing to express our opposition to the proposed hotel project at 5955 Calle Real. After two DRB hearings, the applicant is still not seriously addressing the concerns raised by the board. It is still proposing a three-story building that is architecturally an insult to the Calle Real business and residential community, and the entire City of Goleta at large. The size, bulk, scale, height, massing, and proportions of this building are excessive for the site and for the surrounding area.

The architecture is a conglomeration of shoe-box-styled industrial architecture that looks like a dressed-up garage building found along Highway 101 as one drives to Los Angeles. It is a style of building that belongs to a big city eager for something trendy, but indifferent to its clumsy boxiness.

This is an out-of-town style of architecture that violates the historical character of Calle Real businesses and residential neighborhoods as they have evolved since the 1950s. Like most of Goleta, businesses along Calle Real (including 3 existing hotels) and the surrounding neighborhoods are characterized by one-to-two story buildings of modest scale, that cumulatively convey a small town feel, with clear views of the mountains, roads and sidewalks that are pedestrian friendly, whose buildings have deep setbacks that provide a sense of open space and communal friendliness.

The proposed hotel does nothing to enhance any of the existing built environment values. It is a distracting, inappropriate style of architecture for a project that will create yet more congestion and the loss of mountain views. It is another high-rise, high-density hotel that does not respect the character of our City.

We request that DRB reject this proposal and demand a re-design of the hotel project. A re-design should significantly reduce the size, bulk, scale, height, massing, and proportions of the building to a two-story project sensitive to its visual impacts. Most of all the architectural style of the building must be something that is compatible to the modest scale and distinctive and defining styles found in the Calle Real area.



I am unable to attend the meeting but, as a neighbor to the project, I wanted my voice to be heard with regards to the 3 story, 134-room hotel project at 5955 Calle Real. My concerns are as follows:

- 1) Traffic. This is one of the busiest intersections in Goleta, having to accommodate traffic from Fairview on the other side of the freeway over Hwy. 101. It already takes 3-4 minutes to get through the lights at that intersection. A 134 room hotel will generate an additional 60-70 cars trying to get out of their parking lot each morning and that will slow traffic even more.
- 2) Size: Three stories is totally incompatible with surroundings.
