After careful review of the City's plan to consider rezoning the subject land for residential development, I have to object, well in advance of the City's consideration of potential impacts from such development.

With 20 units per acre on 1.8 acres, a likely total of 36 units could be developed. Must I point out to the City that the entire area is already clogged with dense vehicle traffic? We're looking at a possible traffic increase of seventy or more exiting vehicles, which would need to enter Hollister Ave from South Glen Annie Road. I saw no mention of these factors in the announcement.

Let's be realistic about traffic density in the area. The intersection of Hollister and Storke Road is already a nightmare, with little relief in sight. Evidently, the City has little or no professional traffic engineering capability, as can be seen with the hundreds of vehicles at that intersection, backed up in all four approaches thereto. I dread seeing the annual swarm of vehicles bearing shoppers between now and the Christmas season.

Our young City is rapidly approaching traffic gridlock, from which there can be no after-the-fact relief.

Is it true that our City planners and managers never saw a project they didn't like? I truly believe that it's high time for our City Council to change its policies, which apparently welcome one major development project after another. Long after these officials are gone from office, the impacts of their decisions will remain.

Once more, I am reminded of the County's Planning and Development department's former goal "full build-out of the Goleta Valley", which we worked so hard to overturn by incorporating the City of Goleta in 2002.
