### **RECOMMENDATION:**

A. Conduct candidate interviews for the Parks and Recreation Commission and Public Tree Advisory Commission; and

- B. Select one nominee for the Parks and Recreation Commission mayoral appointment; and
- C. Select two nominees for the Public Tree Advisory Commission mayoral appointment.

# **BACKGROUND:**

The Parks and Recreation Commission is a seven member body with responsibility to provide citizens a platform to discuss the needs, opportunities and current offerings of parks and recreation activities in the City. Each Parks and Recreation commissioner is appointed by the City Council on an at large basis. On March 27, 2019, Ruth McGolpin resigned from the Parks and Recreation Commission.

The Public Tree Advisory Commission is authorized by Goleta Municipal Code Section 2.11.020. The Public Tree Advisory Commission is composed of five members, each of whom must be a resident of the City of Goleta with an interest in and/or experience in helping envision and create urban forests or landscaping. The term of office for each Board member is four years -and is set to expire at the first regular meeting in January. On March 12, 2019 the City Council conducted interviews for the Public Tree Advisory Commission and nominated Paul Saldana and Lawrence Hunt to the Public Tree Advisory Commission and directed staff to re-open the vacancy for recruitment of two positions.

# **DISCUSSION:**

As directed by the City Council on March 12, 2019, the City Clerk's office reopened the vacancy for recruitment of two positions on the Public Tree Advisory Commission as well as the current vacancy on the Parks and Recreation Commission and published requests for candidate applications on the City website, the Monarch Press, Channel 19, the local adjudicated newspaper, and posted at various locations throughout the City.

Staff has received applications from Lindsay Lucera and Jeff Wayco requesting to be interviewed for the Public Tree Advisory Commission. There are two positions open on the Public Tree Advisory Commission. Staff has confirmed the following interview times:
