**SUBJECT:** Fairview Avenue Sidewalk Infill at Stow Canyon Road Project (CIP 9060)

Notice of Completion

### **RECOMMENDATION:**

A. Adopt Resolution No. 19-\_\_\_ entitled "A Resolution of the City Council of the City of Goleta, California, Authorizing the Filing of a Notice of Completion for the Fairview Avenue Sidewalk Infill at Stow Canyon Road Project (9060)"; and

B. Direct the City Clerk to file a Notice of Completion.

### **BACKGROUND:**

The Fairview Avenue Sidewalk Infill at Stow Canyon Road Project (Project) [Capital Improvement Program (CIP) Project No. 9060] is located along the east side of Fairview Avenue fronting the Goleta Branch Library and Fairview Gardens, south of Stow Canyon Road. The project addressed a discontinuity of sidewalk and bottlenecking of the roadway by providing 370 feet of new sidewalk, a second northbound travel lane, and 5-foot wide bicycle lane. Additionally, a pedestrian crosswalk was installed along Stow Canyon Road with Americans with Disability Act Standards (ADA) compliant curb ramps. Public Works is currently working with Southern California Edison on the installation of a streetlight at Stow Canyon Road.

On April 17, 2018, the City Council authorized the City Manager to execute a Professional Design Services Agreement with Cannon Corporation to prepare plans, specifications, and an engineer's estimate for the project.

On November 6, 2018, the project received authorization from the City Council to advertise for construction. At this meeting, the project plans and specifications were also approved. The Public Works Department solicited competitive bids from qualified contractors using the formal bid process required by the California Public Contract Code and the Uniform Construction Cost Accounting Manual on November 15 and November

22, 2018. The City Clerk's office opened the sealed bids at City Hall on December 12, 2018.

On January 15, 2019, the City Council awarded the construction contract to Lash Construction, Inc. (Lash) for the project in a not to exceed amount of \$395,989 and a professional design services agreement to Filippin Engineering, Inc., in an amount not to exceed \$86,800, for construction management, inspection, and testing (CMIT) services.

### **DISCUSSION:**

Construction on the Project began on February 19, 2019. Construction included widening an existing roadway, new concrete sidewalk, curb and gutter, a driveway, a spandrel/cross gutter, ADA compliant curb ramps, drainage improvements, signage, striping and pavement markings on Fairview Avenue per the project plans and specifications.

Lash completed the project on May 23, 2019, consistent with the contract period of 60 working days plus 8 rain days. Over the past month, Public Works and the contractor have finalized the construction invoices, record drawings, and project closeout activities.

Public Works is recommending adoption of the proposed resolution to facilitate the final close-out of this project (Attachment 1). A Notice of Completion pursuant to Public Contract Code §20854 is recommended for approval and direction to be filed with the County of Santa Barbara, County Recorder Office (Attachment 2).

## **FISCAL IMPACTS:**

The construction, construction management, inspection, and materials testing (CMIT), and contingency costs were estimated to be \$561,789. The actual cost for construction, including quantity changes, CMIT and contingency totaled \$490,459, which is under budget. There were no change orders for construction. The total estimated project costs are \$573,216, below the budget authorization of \$690,801. The table below summarizes the total project budget, actual project costs, and remaining budget:

As noted above, the project was funded with a combination of Measure A local funds, Measure A grant funds, and Goleta Transportation Improvement Program (GTIP) funds. The final budget worksheet for the construction and the overall project costs are shown in the tables below.
