SUBJECT: Los Carneros Road Overhead Bridge Replacement Project Notice of

Completion

RECOMMENDATION:

A. Adopt Resolution No. 19-___ entitled "A Resolution of the City Council of the City of Goleta, California, Authorizing the Filing of a Notice of Completion for the Los Carneros Road Overhead Bridge Replacement Project"; and

B. Direct the City Clerk to file a Notice of Completion.

BACKGROUND:

This Los Carneros Overhead Road Bridge Replacement Project (project) replaced the existing structurally deficient Los Carneros Road Overhead Bridge and provided a dedicated right turn lane from Los Carneros Road onto the southbound Highway 101 on-ramp to improve traffic flow. The bridge crosses the railroad tracks owned by the Union Pacific Railroad (UPRR) and is adjacent to the US 101 interchange owned by Caltrans.

On, May 19, 2009 the City Council authorized the City Manager to execute a Professional Design Services Agreement with URS Corporation to prepare plans, specifications, and an engineer's estimate for the project. On September 16, 2013 a professional design services agreement to was awarded to MNS Engineers, Inc, in an amount not to exceed \$86,800, for construction management, inspection, and testing (CMIT) services. On December 17, 2013, the City Council awarded the construction contract to Granite Construction for the project in a not to exceed amount of \$6,324,690.

DISCUSSION:

Construction on the Project began on February 10, 2014. Construction was completed per the project plans and specifications. The project was funded through the Caltrans Highway Bridge Program (HBP) which is comprised of federal funding.

Granite completed the construction project on June 1, 2016, consistent with the contract period of 330 working days plus 252 working days for the 12-month plant establishment

period. Over the next 8 months, Public Works and the contractor finalized the construction invoices, record drawings, and project closeout activities. All final closeout paperwork including the final reimbursement invoice was submitted to Caltrans in February 2017. The project was officially closed out by Caltrans on May 11, 2018.

The Project has long since been completed and accepted by the City Engineer. Though closeout was completed through the Caltrans federal process, project files indicate that a Notice of Completion had not been filed with the County of Santa Barbara. In order to finalize this process, Public Works is recommending adoption of the proposed resolution to facilitate the final close-out of this project (Attachment 1). A Notice of Completion pursuant to Public Contract Code §20854 is recommended for approval and direction to be filed with the County of Santa Barbara, County Recorder Office (Attachment 2).

FISCAL IMPACTS:

There are no fiscal impacts associated with the Notice of Completion. All project related agreements and purchase orders have been closed and all project retention has been released. The table below summarizes the final project costs.
