SUBJECT: Notice of Completion of Improvements to the Athletic Field at the Goleta

Community Center

RECOMMENDATION:

A. Adopt Resolution No. 19-__ entitled "A Resolution of the City Council of the City of Goleta, California, Authorizing the Filing of a Notice of Completion for the Improvements to the Athletic Field at the Goleta Community Center", and

B. Direct the City Clerk to file a Notice of Completion with County Recorder's Office.

BACKGROUND:90

The Improvements to the Athletic Field at the Goleta Community Center project (Project) [Capital Improvement Project No. 9071] consisted of a renovation of the turf area located behind the Goleta Valley Community Center and adjacent to the Goleta Boys and Girls Club. The project was identified in early 2017 and the City submitted a grant application to the State of California Housing and Community Development Department for a Housing Related Parks Program (HRPP) grant. The City was awarded \$269,234.

On June 21, 2019, the City issued a notice to proceed to Landscape Support Services to begin the contracted improvements. The Project removed existing turf, sidewalk and irrigation and replaced it with new equipment, ADA sidewalk, gopher mesh and sod. In addition, the project included extra fencing, the addition of a decomposed granite perimeter path and a fitness station. The space has been modified to expand traditional uses from sports activities to walking, relaxing in the natural shaded areas and fitness training. The improvements of this space have significantly benefited the health and quality of life for youth, seniors and families in the community by greatly improving access to open space and outdoor recreational amenities.

DISCUSSION:

On August 21, 2019, the final walkthrough of the site was completed, and the project determined to be significantly complete. The installation of the sod was the last component of the project completed by the contractor and required the closure of the site until the roots of the sod were well established. On October 2, 2019, the City held a ribbon cutting ceremony to celebrate the official opening of this new recreation space.

The Neighborhood Services and Public Safety Department is recommending adoption of the proposed resolution to facilitate the final close-out of this project (Attachment 1). A Notice of Completion pursuant to Public Contract Code §20854 is recommended for approval and direction requested to the City Clerk to file it with the County of Santa Barbara, County Recorder Office (Attachment 2).

FISCAL IMPACTS:

The construction, contingency, equipment, and construction management, inspection, and materials testing (CMIT) costs were estimated to be \$548,000. The actual cost for construction, including quantity changes, equipment, and construction management, totaled \$488,169.04 which is \$59,839.96 under budget, including the credit of \$5,568 in change orders for construction.

The project was funded with a combination of Park Development Impacts Fees (DIF) (\$279,070) and a grant from the State of California Housing Related Park Program (\$269,234). The final project costs are shown in the table below.

^{*}Recently identified need to purchase a mutt mitt station and new trash cans will increase total project costs by approximately \$3,000 and Park DIF will be used for these purchases.

Any remaining fund balance will be returned to the Park DIF fund until allocated to another project.
