Dear Madam Mayor and Council Members,

I write to urge you to welcome and adopt a resolution to endorse Health Care as A Right and the expanded Medicare for All, Single Payer legislation, Jayapal HR 1384, that has been filed in the House. Though a Federal Act, awaiting passage in the Congress, it represents an ethical policy declaration of profound significance that would assure every Goleta and US resident comprehensive health care that includes a single tier of high quality mental, dental, hearing and vision care services, with no limiting networks and assure full access to any health care professional. Long Term Care, that I advocate be called "Life Time Care", is also a globally covered system.

There are no financial details in this bill as this must and will be determined by the extent of the agreed upon service policy framework and cannot be accurately plotted until the policy scope is established. It is clear and fundamental that all services will be provided with zero out of pocket cost to anyone - no premiums, co-pay or deductibles - nor, any costs that may exceed the flexible rates that would be negotiated among all providers.

We know, with absolute certainty, that savings exceeding \$500 billion would accrue nationally. More than \$37 billion would be saved in California alone. Clearly, the opposition to this paradigm shift in rightful care will be opposed by 'all the money in the world', as the insurance, big Pharma and the Hospital cartel industries would have their profit driven and barbarous care exclusions ended. The threat to them is profound. Thus, their predictable opposition is ferocious, using sophisticated media disinformation and flooding legislators with funds, while challenging their re-elections, to fall in line.

It is imperative that caring public representatives take the strongest and most courageous <u>moral</u> stand on the central policy, **Health Care as a Right,** and understand that the financing structure is absolutely secondary in this first endorsement.
