**SUBJECT:** Selection of Mayor Pro Tempore

#### **RECOMMENDATION:**

A. Select a Mayor Pro Tempore from among the members of the City Council.

B. Appoint the Mayor to serve as the Chair and the Mayor Pro Tempore to serve as the Vice Chair of the Successor Agency to the Redevelopment Agency for the City of Goleta.

#### **BACKGROUND:**

On November 21, 2005, the City Council adopted Resolution No. 05-58 (Resolution) which established procedures for selection of the Mayor and Mayor Pro Tempore. The Resolution provides that the Mayor and Mayor Pro Tempore shall be selected annually by Council from among its members at the first meeting in December, and that they serve at the pleasure of the City Council. A copy of the Resolution is attached to this report for Council's review.

In November 2016, Measure C2016 was approved by a majority of the Goleta voters and provided for the direct election of the Mayor to serve a two-year term beginning with the November 2018 Municipal Election. Therefore, the Resolution now only applies to the appointment of the Mayor Pro Tempore.

On January 17, 2012, the City Council elected to become the Successor Agency to the Redevelopment Agency for the City of Goleta Pursuant to Part 1.85 of Division 24 of the California Health and Safety Code. Council policy and practice regarding the former Redevelopment Agency, has been that the Mayor serves as the Chair and the Mayor Pro Tempore serves as the Vice Chair of the Agency.

#### **DISCUSSION:**

The Resolution calls for the Mayor Pro Tempore to be selected annually at the first meeting in December, which is December 3, 2019 this year. No further procedural protocols are contained in the Resolution, allowing the Council full discretion in selecting the Mayor Pro Tempore. The Council may, therefore, entertain nominations and proceed with a selection for the position.

Consistent with Council policy regarding the former Redevelopment Agency, staff recommends that the Mayor serve as the Chair and the Mayor Pro Tempore serve as the Vice Chair of the Agency.

### **RESOLUTION NO. 05-58**

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLETA, CALIFORNIA, ESTABLISHING PROCEDURES FOR ELECTION OF MAYOR AND MAYOR PRO TEMPORE

**WHEREAS**, the City Council has determined that it is appropriate to establish a policy with regard to the selection of Mayor and Mayor Pro Tempore; and

WHEREAS, the California Attorney General has determined that the term of office for Mayor and Mayor Pro Tempore is indefinite and subject to the pleasure of the City Council; and

**WHEREAS,** the City Council has determined that it is appropriate to establish a policy with regard to service by the Mayor and Mayor Pro Tempore at the pleasure of the City Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GOLETA DOES RESOLVE, DETERMINE, FIND AND ORDER AS FOLLOWS:

# SECTION 1.

- A. The Mayor and Mayor Pro Tempore shall be selected annually by Council from among its members at the first meeting in December
- B. The Mayor and Mayor Pro Tempore shall serve at the pleasure of the City Council and until such time as a new Mayor and Mayor Pro Tempore are selected and assume office.
