SUBJECT: Vacation of Street Rights-of-Way on Los Carneros Road and Calle Real

RECOMMENDATION:

A. Conduct a public hearing to hear all persons interested in or objecting to the proposed vacation of street rights-of-way on Los Carneros Road and Calle Real;

- B. Adopt Resolution No. 20-____, entitled "A Resolution of the City Council of the City of Goleta, California, Ordering the Vacation of an Excess Portion of Los Carneros Road Right-Of-Way Adjacent to the Property Located at 6491 Calle Real, APN 077-160-040, and Providing for the Recordation of this Resolution";
- C. Adopt Resolution No. 20-____, entitled "A Resolution of the City Council of the City of Goleta, California, Ordering the Vacation of Certain Excess Portions of Los Carneros Road and Calle Real Rights-Of-Way Adjacent to the Property Located at 302 Los Carneros Road, APN 077-160-064, and Providing for the Recordation of this Resolution"; and
- D. Authorize the City Manager to execute all right-of-way documents necessary to complete the property exchange with the current owners of the properties located at 6491 Calle Real and 302 Los Carneros Road, in accordance with the property exchange agreements approved by City Council on July 15, 2014.

BACKGROUND:

In 2012, the City of Goleta designed the Los Carneros/Calle Real Roundabout Project. During design, it was determined that in order to construct the improvements, certain additional rights-of-way were required from adjacent properties and certain excess portions of street rights-of-way would not be needed after completion of the project.

On July 15, 2014, City Council approved property exchange agreements with Lynn C. Sturgeon Revocable Trust, then-owner of the adjacent property located at 6491 Calle Real with County of Santa Barbara assessor's parcel number (APN) 077-160-040, and with the Islamic Society of Santa Barbara, the owner of the adjacent property located at 302 Los Carneros Road with APN 077-160-064. The property exchange agreements, among other terms and conditions, provided for right-of-way dedications to the City of

privately-owned areas along the Calle Real and Los Carneros Road frontages that were needed for construction of the City's Los Carneros Road/Calle Real Roundabout Project. In exchange for these right-of-way dedications, the City agreed to vacate and convey to these adjacent property owners areas along the parcel's Los Carneros Road and Calle Real frontages that were no longer needed for the project or public street purposes. These right-of-way dedications and proposed vacations are shown in Attachment 1 to this report.

The City did not want to vacate the public street right-of-way and complete the exchanges until the Los Carneros/Calle Real Roundabout Project construction was fully completed and integrated into the public street system, so this exchange was postponed until the project was completed. In accordance with the terms of the original property exchange agreements, the City is required to complete the vacations and conveyance of the public street rights-of-way as shown in Attachment 1.

On December 17, 2019, City Council adopted Resolution No. 19-75 and Resolution No. 19-76 to declare its intention to vacate the excess portions of Los Carneros Road and Calle Real rights-of-way, to schedule these public hearings on February 4, 2020, and to hear any persons interested in or objecting to the proposed vacations. The City Council's Resolutions also required the posting of notices of these hearings along the portions of Los Carneros Road and Calle Real rights-of-way proposed to be vacated, and also required the publication of the City Council Resolutions in a qualifying publication of general circulation.

The right-of-way vacations and dedications for 6491 Calle Real (Sturgeon) property, APN 077-160-040 are described in Attachment 2 and 3. In 2017, the Sturgeon property was conveyed by the 2012 Lynn C. Sturgeon Revocable Trust to a new owner, 6491 Calle Real Partners, LLC, which is the successor in interest to the Sturgeon interests in the property exchange agreement. The right-of-way vacations and dedications for 302 Los Carneros Road (Islamic Society of Santa Barbara) property, APN 077-160-064 are described in Attachment 5 and 6.

DISCUSSION:

In accordance with the provisions of the property exchange agreements that were approved by City Council in 2014, the City contractually agreed to convey the excess land areas to the adjacent property owners in exchange for right-of-way needed from the owners for the Los Carneros/Calle Real Project. Now that construction of the roundabout is complete and use of the excess areas as a public street is discontinued, the City must initiate steps set forth in the applicable sections of the California Streets and Highways Code, the Vacation Law, to hear all persons interested in or objecting to the proposed vacation of the excess portions of the Los Carneros Road and Calle Real rights-of-way. All actions required in accordance with the California Vacation Law have been completed related to these public hearings.

The proposed resolutions (Attachment 4 and 7), if adopted by Council following the public hearings, will order the vacation of the excess portions of Los Carneros Road and Calle Real rights-of-way adjacent to 302 Los Carneros Road and adjacent to 6491 Calle Real, and will authorize the City Manager to execute all supplemental right-of-way documents

necessary to complete the conveyances of the underlying fee interests in said vacated areas and finalize the acceptance of necessary conveyances from the property owners to the City in accordance with the prior Property Exchange Agreement dated July 7, 2014, between the City of Goleta and the Islamic Society of Santa Barbara, and the Property Exchange Agreement dated August 31, 2012, between the City of Goleta and the 2012 Lynn C. Sturgeon Revocable Trust.

FISCAL IMPACTS:

There are no financial impacts specific to this action aside from processing costs.

ALTERNATIVES:

Because the City has already entered into the property exchange agreements to vacate the excess road rights-of-way and exchange property interests, the Council has no alternative but to follow through with the process.







RESOLUTION NO. 20-____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLETA, CALIFORNIA, ORDERING THE VACATION OF AN EXCESS PORTION OF LOS CARNEROS ROAD RIGHT-OF-WAY ADJACENT TO THE PROPERTY LOCATED AT 6491 CALLE REAL, APN 077-160-040, AND PROVIDING FOR THE RECORDATION OF THIS RESOLUTION

WHEREAS, on December 17, 2019, the City Council adopted Resolution No. 19-75, declaring its intention to vacate the excess portion of Los Carneros Road right-of-way adjacent to 6491 Calle Real, Santa Barbara County Assessor's Parcel No. 077-160-040, within the City of Goleta, which is hereinafter referred to as the "Public Street Interests"; and

WHEREAS, on February 4, 2020, during the regularly scheduled Council meeting, the Goleta City Council held a hearing upon the proposed vacation of the Public Street Interests for all persons interested in or objecting to the vacation; and

WHEREAS, the above referenced hearing was duly noticed and held pursuant to Division 9, Part 3, Chapter 3 (Sections 8320-8325) of the Streets and Highways Code of the State of California as amended; and

WHEREAS, the City Council has caused Notices of Vacation to be posted in the manner and during the time required by Division 9, Part 3, Chapter 3 of the Streets and Highways Code of the State of California; and

WHEREAS, the Council of said City has caused the City Clerk to publish the notice of the hearing on the proposed vacation of the Public Street Interests in a weekly newspaper of general circulation, published and circulated in the City of Goleta as required by Division 9, Part 3, Chapter 3 of the Streets and Highways Code of the State of California; and

WHEREAS, The City of Goleta, as successor of the County of Santa Barbara, owns that certain strip of land underlying the Public Street Interests for Los Carneros Road right-of-way in fee, as granted and described originally in that

certain grant deed to the County of Santa Barbara recorded on May 18, 1967, as Instrument No. 13555, in Book 2190 at Page 1331, in the Official Records in the Office of the County Recorder of the County of Santa Barbara; and

WHEREAS, in conjunction with vacating the Public Street Interests, the City seeks to also relinquish fee ownership rights in the excess land area underlying the Public Street Interests in exchange for other right-of-way required by City for the Los Carneros Road and Calle Real Project, as set forth in that certain agreement between Lynn C. Sturgeon, Trustee of the 2012 Lynn C. Sturgeon Revocable Trust ("Sturgeon Trust"), the former owner of the real property at 6491 Calle Real, APN 077-160-040, and the City of Goleta, dated August 31, 2012.

NOW, THEREFORE, PURSUANT TO THE PROVISIONS OF DIVISION 9, PART 3, CHAPTER 3 OF THE STREETS AND HIGHWAYS CODE OF THE STATE OF CALIFORNIA, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLETA, AS FOLLOWS:

SECTION 1.

Pursuant to Streets and Highways Code sections 8330 et seq., the City of Goleta approves the proposed vacation of the Public Street Interests in that certain portion of Los Carneros Road right-of-way, as described herein for the following reasons:

- 1. The above findings are true and correct.
- 2. The Public Street Interests for the excess portion of Los Carneros Road right-of-way, as described herein, are not necessary for the present or prospective public street right-ofway purposes and nonmotorized transportation facilities, subject however, to the reservation therefrom of certain non-exclusive easement rights.

SECTION 2.

The City of Goleta hereby vacates the Public Street Interests in that certain portion of Los Carneros Road, in the City of Goleta, County of Santa Barbara, State of California, more particularly described in Exhibit A, and depicted in Exhibit B, each attached hereto and incorporated herein, excepting and reserving therefrom the following non-exclusive easement rights;

1. Excepting and reserving therefrom, on behalf of Frontier California Inc., a corporation, a non-exclusive easement and right-of-way for the purpose of

constructing, using, maintaining, operating, altering, adding to, repairing, replacing, reconstructing, inspecting and/or removing its facilities consisting of but not limited to: underground conduits, manholes, hand holes, cables and/or facilities (hereinafter sometimes called "equipment") necessary or useful for the transmission of electric energy for communications, telecommunications, video, intelligence by electrical means and/or other purposes on, over, in, under, across, along that certain real property described in Exhibit A and depicted in Exhibit B.

2. Excepting and reserving therefrom, on behalf of Southern California Edison Company, a corporation, its successors and assigns, a non-exclusive easement and right-of-way to construct, use, maintain, operate, alter, add to, repair, replace, reconstruct, inspect and remove at any time and from time to time underground electrical supply systems and communication systems (hereinafter referred to as "systems"), consisting of wires, underground conduits, cables, vaults, manholes, handholes, and other appurtenant fixtures and equipment necessary or useful for distributing electrical energy and for transmitting intelligence, data and/or communications (e.g., through fiber optic cable), in, on, over, under, across and along that certain real property described in Exhibit A and depicted in Exhibit B.

SECTION 3.

The Council of the City of Goleta hereby directs and authorizes the City Manager to complete the conveyance of the fee rights underlying the Public Street Interests vacated herein in accordance with the terms and provisions of that certain agreement entered into between Lynn C. Sturgeon, Trustee of the 2012 Lynn C. Sturgeon Revocable Trust ("Sturgeon Trust"), the former owner of the real property at 6491 Calle Real, APN 077-160-040, and the City of Goleta, dated August 31, 2012.

SECTION 4.

That the City Clerk of the City of Goleta is instructed to cause the recordation of the certified original of this resolution in the Official Records, in the Office of the County Recorder of the County of Santa Barbara, at which time that excess portion of the Public Street Interests in that certain portion of Los Carneros Road right-of-way

being vacated will no longer be a portion of said public street.

SECTION 5.

The City Clerk shall certify to the adoption of this resolution and enter it into the book of original resolutions.

RESOLUTION NO. 20-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLETA, CALIFORNIA, ORDERING THE VACATION OF CERTAIN EXCESS PORTIONS OF LOS CARNEROS ROAD AND CALLE REAL RIGHTS-OF-WAY ADJACENT TO PROPERTY LOCATED AT 302 LOS CARNEROS ROAD, APN 077-160-064, AND PROVIDING FOR THE RECORDATION OF THIS RESOLUTION

WHEREAS, the Council of the City of Goleta, by Resolution No. 19-76, adopted on December 17, 2019, has declared its intention to vacate the excess portions of Los Carneros Road and Calle Real rights-of-way adjacent to 302 Los Carneros Road, Santa Barbara County Assessor's Parcel No. 077-160-064, within the City of Goleta, which are hereinafter referred to together for convenience as the "Public Street Interests"; and

WHEREAS, The City of Goleta, as successor of the County of Santa Barbara, owns those certain strips of land underlying the Public Street Interests for Los Carneros Road and Calle Real rights-of-way in fee, as granted and described originally in that certain grant deed to the County of Santa Barbara recorded on May 18, 1967, as Instrument No. 13555, in Book 2190 at Page 1331, and as granted and described originally in that certain grant deed to the County of Santa Barbara recorded on August 9, 1967, as Instrument No. 22695, in Book 2201 at Page 138, both in the Official Records in the Office of the County Recorder of the County of Santa Barbara; and

WHEREAS, on February 4, 2020, at 5:30 pm, during the regularly scheduled Council meeting, the Goleta City Council held a hearing upon the proposed vacation of the Public Street Interests for all persons interested in or objecting to the vacation; and

WHEREAS, the above referenced hearing was duly noticed and held pursuant to Division 9, Part 3, Chapter 3 (Sections 8320-8325) of the Streets and Highways Code of the State of California as amended; and

WHEREAS, the City Council has caused Notices of Vacation to be posted in the manner and during the time required by Division 9, Part 3, Chapter 3 of the Streets and Highways Code of the State of California; and

WHEREAS, the Council of said City has caused the City Clerk to publish the notice of the hearing on the proposed vacation of the Public Street Interests in a weekly newspaper of general circulation, published and circulated in the City of Goleta as required by Division 9, Part 3, Chapter 3 of the Streets and Highways Code of the State of California; and

NOW, THEREFORE, PURSUANT TO THE PROVISIONS OF DIVISION 9, PART 3, CHAPTER 3 OF THE STREETS AND HIGHWAYS CODE OF THE STATE OF CALIFORNIA, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLETA, AS FOLLOWS:

SECTION 1.

Pursuant to Streets and Highways Code sections 8330 et seq., the City of Goleta approves the proposed vacation of the Public Street Interests in those certain portions of Los Carneros Road and Calle Real rights-of-way, as described herein for the following reasons:

- 1. The above findings are true and correct.
- 2. The Public Street Interests for the excess portions of Los Carneros Road and Calle Real rights-of-way, as described herein, are not necessary for the present or prospective public street right-of-way purposes and nonmotorized transportation facilities, subject however, to the reservation therefrom of certain non-exclusive easement rights, other than for a public street.

SECTION 2.

The City of Goleta hereby vacates the Public Street Interests in those certain portions of Los Carneros Road and Calle Real, in the City of Goleta, County of Santa Barbara, State of California, more particularly described in Exhibits A and B, and depicted in Exhibits A-1 and B-1, all attached hereto and incorporated herein, excepting and reserving therefrom the following non-exclusive easement rights;

1. Excepting and reserving therefrom, on behalf of The Southern California Gas Company, a Sempra Energy Company, a non-exclusive easement within said portion of Los Carneros Road described on

Exhibit B and depicted on Exhibit B-1, for continued use and operation of existing facilities, and to lay, construct, maintain, operate, repair, replace, patrol, change the size of, add to, or remove from time to time, as deemed necessary by The Southern California Gas Company, one or more pipelines and conduits, together with metering, measuring, regulating, cathodic protection, communications and other appurtenances.

- 2. Excepting and reserving therefrom, on behalf of Frontier California Inc., a corporation, a non-exclusive easement within said portion of Los Carneros Road described in Exhibit B and depicted on Exhibit B-1, for the purpose of constructing, using, maintaining, operating, altering, adding to, repairing, replacing, reconstructing, inspecting and/or removing its facilities consisting of but not limited to: underground conduits, manholes, hand holes, cables and/or facilities (hereinafter sometimes called "equipment") necessary or useful for the transmission of electric energy for communications, telecommunications, video, intelligence by electrical means and/or other purposes.
- 3. Excepting and reserving therefrom, on behalf of Southern California Edison Company, a corporation, its successors and assigns, a non-exclusive easement within said portion of Los Carneros Road described in Exhibit B and depicted on Exhibit B-1, to construct, use, maintain, operate, alter, add to, repair, replace, reconstruct, inspect and remove at any time and from time to time underground electrical supply systems and communication systems (hereinafter referred to as "systems"), consisting of wires, underground conduits, cables, vaults, manholes, handholes, and other appurtenant fixtures and equipment necessary or useful for distributing electrical energy and for transmitting intelligence, data and/or communications (e.g., through fiber optic cable).

SECTION 3.

The Council of the City of Goleta hereby directs and authorizes the City Manager to complete the conveyance of the fee rights underlying the Public Street Interests vacated herein in accordance with the terms and provisions of that certain agreement entered into between The Islamic Society of Santa Barbara, the owner of the real

property at 302 Los Carneros Road, APN 077-160-064, and the City of Goleta, dated July 7, 2014.

SECTION 4.

That the City Clerk of the City of Goleta is instructed to cause the recordation of the certified original of this resolution in the Official Records, in the Office of the County Recorder of the County of Santa Barbara, at which time those excess portions of the Public Street Interests in those certain portions of Los Carneros Road and Calle Real rights-of-way being vacated will no longer be a portion of said public streets.

SECTION 5.

The City Clerk shall certify to the adoption of this resolution and enter it into the book of original resolutions.






