B.1 Public Hearing to Consider Case No. 19-013-TEX: Time Extension Request for Cottage Medical Office Building Project (formerly Somera Medical Office Building Project).

Staff recommends that the Planning Commission:

Case No. 19-013 TEX: Cottage Medical Office Building Project

Site visits and ex-parte conversations: Commissioner Shelor reported a recent site visit. Chair Smith, Commissioner Fuller, and Commissioner Maynard each reported no disclosures. Commissioner Shelor reported when this project was before the Design Review Board, approximately five years ago, he participated in that review.

The staff report was presented by Mary Chang, Supervising Senior Planner, and Brian Hiefield, Associate Planner, including a PowerPoint presentation entitled, "Time Extension Request for Cottage Medical Office Building Project (19-013-TEX), City of Goleta Planning Commission, January 13, 2020".

The applicant's presentation was made by agent Steve Fort, with SEPPS; and Scott Allen, director of construction management for Santa Barbara Cottage Hospital, who spoke in support of the project and the extension.

Commissioner Maynard agreed with the previous two requests by Commissioner Shelor for information from staff and expressed her interest in these two topics.
