Respected Mayor and members of the Council:

I would encourage you to strenuously condemn police brutality and racism. I would suggest you also propose steps to define and implement actions that could be taken or supported by the city to both change the negative prejudices that exist in many, and to restrain the expression of whatever racism may be present in our community by all who live and work here, in addition to law enforcement personnel.

I suggest that declaring racism a public health emergency, however, would not be beneficial. The common understandings of both "public health" and "emergency" do not support such a declaration. Racism is a disease of the soul, not the body. Were one to use a health analogy, racism is a debilitating, potentially fatal, resistant cancer, not a stroke or heart attack: a chronic disease, not an emergency. Eliminating it requires well planned, long term, aggressive treatment. This resolution may appear more to be empty posturing than a serious attempt to begin a long, hard process of study, discussion, and action.

I would propose instead that today the Council passionately condemn police brutality and racism AND that the council declare its intent to create an ongoing mechanism to welcome public input and to sponsor staff research into ways to reduce race-based prejudice and injustice. This should be targeted toward both City policies and operations, and the presence of racism throughout our community. Perhaps a standing committee could be created with a timeline calling for an initial report of specific proposals to be made by a specified date, including a plan for ongoing work with target dates for implementation and updates. Thank you for opening a discussion of these issues and for allowing public input through a variety of mechanisms.

The tragic death high lighted the effects of systemic racism and the level of racial tensions that fester throughout our society.

Punishment through condemnation and the implication to eliminate the enforcement personnel would create a lot of noise but little substance in return.

If 'Racism' is considered a 'Public Health Emergency', please inform me where I could obtain some health emergency treatments and what are these treatments?

Punishment alone does not and would not achieve any long term lasting effect on the behavior of certain rogue officer(s) who took the interpretation of the law in his/her own hands.

It is my belief that greater than 99.90% of the officers are psychological balanced with a deeply rooted desire to serve the public, or he/she would not take on this type of work as their sole profession in life.

The law enforcement community should not be painted over with the same brush and color of ink for all of its members.

I applaud and strongly support the efforts to improving police enforcement policies and increasing transparency of the Sheriff's department.

I like and support the proposed letter on police brutality (relevant section referenced below), but I thought it lacked "teeth". I don't know the status or details of the contract between the city and the Sheriff's Dept., but I think it would be wise to integrate some of these "requests" into the existing contract or have one or more become prerequisites to the renewal of said contract. Otherwise it feels like a bunch of platitudes.

For instance, line 2 – "Disbanding internal department investigations of police misconduct." is an item I think you could have integrated as a requirement in current or future City/Sheriff agreements.

Some requests will remain subjective (e.g. "Prioritization of mental health services..."), but many could have objective criteria added to them and / or deadline dates applied to them. Deadline dates could be negotiated with the Sheriff, so as not to be too onerous, administratively.

Please read the following on our behalf to be read into the record at the council meeting today.

In light of the extraordinary events surrounding the horrific police murder of George Floyd, we need to reform the police practice of using force. We favor a national standard, but until that happens we should adopt policies locally that will likely be in line with a National Standard once it passes. We would suggest the following to be incorporated as policy because we have evidence they will reduce unnecessary police assaults and killings:

- 1. Require all alternatives (ie tazor) of force to be used before shooting. the objective of force should be submission and compliance, not assult of killing.
- 2. Require all use of force to be reported as a matter of police record.
- 3. Dismissal of police officers with repeated complaints of abuse (regardless of union protections)
- 4. Ban Chokeholds
- 5. Require officers to intervene (and report) the use of excessive force by other officers.
- 6. Require officers to announce they are police and are about to shoot their guns with deadly force if the suspect does not comply with direction.
- 7. An annual independent (community group) review of police performance
- 8. Require all body cameras to be on.

I was horrified to see the video of the killing of George Floyd and I continue to be outraged by the continued reports we have heard from across the nation about the killing of our black brothers and sisters by law enforcement officials. 

Dear Mayor and Council Members,

My name is Phebe Mansur. I am a resident and business owner in Goleta Old Town.

I devoted 10 years to working with homeless in my neighborhood. Former Community Resource Officer Deputy Dave Valadez was the officer whom I interacted with the most. It is my opinion that he represents the best of the best of law enforcement. I witnessed first-hand his quiet strength, kindness, and patience while dealing with recalcitrant individuals.

There are acts of brutality documented against all ethnicities. We currently have a Goleta resident who is a Caucasian male who was subjected to police brutality. He was: 1) injured by the officer which resulted in permanently disabling him, 2) wrongfully arrested, imprisoned, and later fully acquitted, and 3) subjected to on-going harassment by Goleta police - - This Goleta resident is worthy of the same attention, regardless of his skin color.

Brutality acted upon any sentient being, human or otherwise, is inexcusable. But when brutality is wielded unjustly and with disregard by trusted public servants (law enforcement), the act is not only inexcusable, but it is a betrayal. In order for law enforcement to be effective, there must be trust. Action needs to be taken to eliminate or at least reduce future incidences.

The proposed resolution as it is currently written excludes by omission all other ethnicities by calling out a specific ethnic group. Calling a single ethnic group when all groups are abused gives priority to this specific ethnicity and is demeaning to those groups which are not called out - - either identify the laundry list of all groups or none.

We live in a good land where community members treat each other most of the time with kindness and respect. In 2018 Goleta ranked #53 of the safest cities in California to live and out ranked Santa Barbara which came in at #283. During the CCP virus pandemic, our community came together and supported each other – making and donating masks to those in need, offering to run errands, and other unheralded acts of kindness. We should be proud that we are active participants in creating one of the safest, most accepting, and least racist communities in our nation.

We may be listed as one of the safest California cities, but we have at least one case of police brutality, and that is one too many. We need to encourage ongoing law enforcement training programs to

continue to produce many more officers with the attitude and skill set of former Deputy Dave Valadez who was loved by all who knew him.

There is another side to this issue that has yet to be mentioned: the community also has a responsibility to having a safe community: abiding the rule of law is a responsibility for which the community is accountable; and trusting law enforcement is another. That trust has been called into question by those in other California counties and other states. It is incumbent upon the City to ensure adequate training of law enforcement and providing opportunities for the community to establish positive relationships with law enforcement, such as participating in National Night Out or other public relation events.

It is my opinion that the City of Goleta might consider issuing a proclamation in honor of residents and businesses who sacrificed of themselves some of whom suffered financially, mentally, and in ways we cannot understand at this time, to comply with the lockdown measures to 'flatten the curve'. We should also recognize fire, law enforcement and medical staff who continued to work to keep our community operational and safe.

Should the City feel the need to issue a proclamation, it should be on behalf of <u>all</u> community members regardless of ethnicity, religious persuasion, or sexual orientation.

As always I appreciate my First Amendment Right to free speech and the opportunity to express my views.

Where possible, defund the police from being the cleanup crew for our society's "problems." Instead, turn the police into a positive and

<u>productive part</u> of our community effort to make us a better community <u>for everyone</u>. Turn policing into a <u>positive</u> part of our public health program reflecting a good, compassionate and healthy community in which one person going to jail or the building of one more prison is seen as a failure. Why should be strive for anything less?

Thank you for proposing the resolution regarding Police Brutality and Racism as a Public Health Emergency. These are critical issues facing our nation and, since we have so far failed to take a stand, it is vitally important that we do so now. I fully support the spirit behind this resolution, but I don't think it goes far enough. I would submit the following suggestions and questions to consider:

- * Please edit this document to capitalize the word "Black." In the words of Lori L. Tharps, "Black with a capital B refers to people of the African diaspora. Lowercase black is simply a color." More on why this is an important distinction can be found here https://cssp.org/2020/03/recognizing-race-in-language-why-we-capitalize-black-and-white/.
- * Can you confirm how much of our local budget is allocated to police? How does that compare to budget allocations for mental health resources, education, and the arts? If I'm reading the "Budget in Brief" correctly, the annual planned expenditures for the city are on the order of \$40-50M and the police force is slated to get \$8M of that. This seems disproportionate to the policing needs for a city the size of Goleta with the crime footprint of Goleta.
- * Finally, I urge you to be more specific in your language around "updating use of force policies." The 8can'twait organization seems to have experts making clear recommendations on use of force by police (https://8cantwait.org/).

Again, I want to praise and support the impulse behind this resolution, but I also know that Goleta the Goodland can and should do better and go further in our mission to disband the systematic White Supremacy that has formed the underpinning of our nation for over 200 years.
