Dear Vito / Jaime:

I rec'd the text of the meeting tomorrow, August 4th, for the "pending" Homekey program grant.

My husband, Rob Widiner, and I live on La Patera Lane @ Goleta and are writing in to SUPPORT the City's application for the Homekey program (for the purchase of the Super 8 Motel for temp/supportive housing AND also permanent housing for the homeless community).

Given the 2 recent fires on Hwy 101, and the general health/unsanitary conditions stemming from living on the streets, we support this SAFE and STRUCTURED alternative.

I like that the County's Behavior Wellness group will have involvement plus the on-site security guard presence (to protect ALL the residents living there and the community).

It is heartbreaking to see the homeless in our community, especially women who I feel are even more vulnerable in this situation, and I admire your pro-active actions on chasing down this grant.

My husband and I have some familiarity with this population. We are conservators of his brother, John, who is 59 years old and was on the verge of being homeless (due to mental health issues and not being able to keep a steady job). John's housing is now stabilized, he meets the financial criteria (for low income housing) of the SB Community Housing Corp, and he is receiving counseling from the County's Behavior Wellness Group. John's personality is unpredictable and he refuses to take any medication, but we are doing our best to create stability for him under those circumstances – just having a place for him to live is a huge relief for his family.

Hopefully the Goleta Council and the citizens of Goleta also understand this dynamic - this is an EXCELLENT first step, but it is not a PERMANENT solution to the homeless situation. When you create an environment with "rules and behavioral expectations" (that are required for general safety), there will be some who do not want to accept this option. In our opinion, though, this project is a HUGE positive step in the right direction.

Once this project is approved and finalized, perhaps a non profit entity could be created to assist with future operational costs (so the broader community can continue supporting it).

Dear Mayor Perotte and Councilmembers,

I write in strong support of the Project Homekey grant proposal and urge the city to send a letter in support of the County Housing Authority's project application.

We know that the issue of people experiencing homelessness remains a major challenge in Santa Barbara County (see 2020 Point in Time County data) and it is expected that housing insecurity will only get worse due to the COVID-19 crisis. Goleta residents know that homelessness is not just a "Santa Barbara" problem. We have unsheltered neighbors along the US 101, out on the Ellwood bluffs, and in other parts of our city. Our unsheltered neighbors are at greater risk of early death than their sheltered counterparts. These unprecedented times call for unprecedented solutions.

According to the National Alliance to End Homelessness, permanent supportive housing is a critical solution for helping to end chronic homelessness: https://endhomelessness.org/ending-homelessness/solutions/permanent-supportive-housing/

According to the recent Grand Jury report, permanent supportive housing in Santa Barbara County is lacking.

This proposal furthers many of the requested goals/outcomes in the recent grand jury report and also appears to be consistent with the city's draft Homelessness Plan.

I agree with the staff recommendation to conduct as much outreach on this project as possible, both to nearby Old Town businesses and to residents. Outreach is a real challenge in the current climate - I am not sure if there is a budget available for flyers/mailings, but if so I strongly support some sort of additional outreach measure beyond just email. Non-profit partners may also be a resource to help get the word out about the project.

Roaming homeless will kill what's left of Goleta business. It would become like downtown and no one would want to be in the area unless absolutely necessary. Homelessness isn't one thing.
