- SUBJECT: Notice of Completion for the 2019 Miscellaneous Concrete Repair Project

RECOMMENDATION:

- A. Adopt Resolution No. 21-____ entitled "A Resolution of the City Council of the City of Goleta, California, Authorizing the Filing of a Notice of Completion for the 2019 Miscellaneous Concrete Repair Project"; and
- B. Direct the City Clerk to file a Notice of Completion.

BACKGROUND:

The City has a project to annually inspect, evaluate, and perform miscellaneous concrete repairs citywide, including removing and replacing damaged concrete sidewalks, driveways, curb and gutters, and access ramps on various streets within the City of Goleta. Public Works Department staff (Public Works) completed design for the 2019 Miscellaneous Concrete Repair Project and on December 3, 2019, the City Council approved the Contract Documents for the project and authorized staff to advertise the project for bids for construction.

Public Works solicited competitive bids for the project on December 12, 2019, and sealed bids were opened on January 23, 2020. On March 17, 2020, the City Council awarded a Construction Contract for the 2019 Miscellaneous Concrete Repair Project to JJ Fisher Construction, Inc. (JJ Fisher) for a not-to-exceed amount of \$203,300 and authorized the City Manager to approve contingency contract change orders in a not-to-exceed amount of \$40,660.

DISCUSSION:

Construction of the 2019 Miscellaneous Concrete Repair Project began on June 15, 2020. Project improvements included removing and replacing damaged and lifted sidewalks, driveways, curb & gutters, ADA access ramps, and parkways on various street within the City of Goleta. JJ Fisher completed the construction work on October 16, 2020, within the construction contract working days for the project. The project construction was completed underbudget and no change orders were issued during construction. Public

Works and the contractor have finalized the construction paperwork, punch list items, and project closeout activities.

Public Works is recommending adoption of the proposed resolution to facilitate the final close-out of this project (Attachment 1). A Notice of Completion pursuant to Public Contract Code §20854 is recommended for approval and direct the City Clerk to file the Notice of Completion with the County of Santa Barbara, County Recorder Office (Attachment 2).

FISCAL IMPACTS:

The total construction cost for the 2019 Miscellaneous Concrete Repair Project was \$220,703 and is shown in the following tables. There were no change orders for construction.
