Santa Barbara Channelkeeper supports the inclusion of Goleta's Creek and Watershed Management Plan (CWMP) implementation into the City's Strategic Plan. Santa Barbara Channelkeeper is a local environmental nonprofit with the mission to protect and restore the Santa Barbara Channel and it's watersheds through science-based advocacy, education, field work, and when necessary, enforcement. Channelkeeper served on the Technical Advisory Committee during the development of the CWMP and additionally, has monitored the water quality of the creeks throughout the Goleta Valley watershed since 2002. We supported the City's adoption of the CWMP in November 2020 and believe that including CWMP implementation in the City's Strategic Plan is a critical next step in the process of protecting, restoring, and effectively managing the important environmental resources within the City of Goleta.

Channelkeeper has engaged more than 600 volunteers to help with collecting water quality data in the 12 creeks that run through the City of Goleta over the last 19 years. This long-term water quality data set is an invaluable resource that helps to tell the status of the creeks in the watershed, identify sources of pollution, and can be used to help guide policy decisions. The data that we've collected over the years illustrates that that many of the creeks that flow through the City are impaired for various parameters. Beyond documenting the current status and impairments of these creeks, the CWMP includes an implementation program section which describes 15 programs to address the impairments identified in the plan. Including the CWMP implementation in the City's Strategic Plan provides the necessary framework for being able to proceed with these programs outlined and thus make progress towards addressing water quality issues in the City.
