STATISTICS

Circulated 31,362 items in September; this up 141% over last year when we were just offering Sidewalk Service.

❖There were 1,003 uses of the wireless network outside of the library; normally we have around 400-500.






PROGRAMMING STATISTICS

17 Children's, Teen and Adult Virtual Programs were held with a total of 399 views.

7,067 PATRONS VISITED THE LIBRARY IN SEPTEMBER.




ISLA VISTA GRANT

STAFF RECRUITMENTS

HR & Library Administration were kept very busy recruiting for & filling 8 positions, only 1 of which was at the branches.





BLACK GOLD

- Santa Barbara made a unilateral decision to leave shared catalog/circulation system, making materials sharing difficult and expensive.
- San Luis Obispo may be doing the same.
- BG hiring a lawyer to look at the outdated JPIA and determine allocations of jurisdictional liabilities (BG staff pensions, contracts, etc.)
- This is a very fraught time for BG and its member libraries.
- Goleta staff are working to preserve regional cooperation and protect our patrons' interests
